

## Unilateral License to Use Microsoft Software Products in Vietnam

Microsoft Corporation, or one of its affiliates, grants to non-governmental organizations (each an “NGO”) in Vietnam a limited, non-transferable, royalty-free right to use Microsoft software products for their organizations’ purposes. This license expires on the earlier of January 1, 2020 or the date the NGO is otherwise licensed under an applicable Microsoft licensing program. For purposes of this license, an eligible NGO shall be as defined [here](#). The Microsoft software products are not licensed for import, export, or resale. No other rights are granted. Warranties and product support are not included in this license. In the event of a conflict between these license terms and those that came with the Microsoft software products, these license terms control with respect to such conflicting terms. An eligible NGO’s use of the Microsoft software products constitutes its acceptance of these license terms.

**Link 1:** For purposes of the Unilateral License to Use Microsoft Software in PRC, “Eligible NGO” means an NGO with the following characteristics:

All non-governmental organizations that:

- (1) operate on a not-for-profit basis;
- (2) are registered or otherwise recognized by one or more international non-governmental organizations; and
- (3) have a publicly beneficial mission. This mission may include, but is not limited to, the following:
  - Providing relief to the poor
  - Advancing education
  - Improving social welfare
  - Preserving culture
  - Preserving or restoring the environment
  - Promotion of human rights
  - Establishment or development of civil society.

For the purposes of the unilateral license, eligible organizations also include independent media organizations that are non-governmental and operate for the purpose of advancing public interests. Examples of such organizations include small newspapers, members of a local media association or those recognized by international media or press freedom organizations.

Not included in this definition are:

- Organizations that are established by the government or rely upon the government as their sole source of funding
- Educational institutions that qualify for Microsoft academic licensing programs
- Healthcare organizations
  - **Exception:** Certain health clinics that provide services for free or on an ability-to-pay basis may be eligible.
- Organizations that exist for the promotion of playing of professional sports
- Political, labor, or fraternal organizations
- Religious organizations
  - **Exception:** Separate charitable entities with a secular community service or project may be eligible.
- Commerce and trade associations without charitable aims or activities
- Sponsorship or fundraising events, activities or tournaments
- Refurbishers or other entities that install the donated software or distribute the computers
