

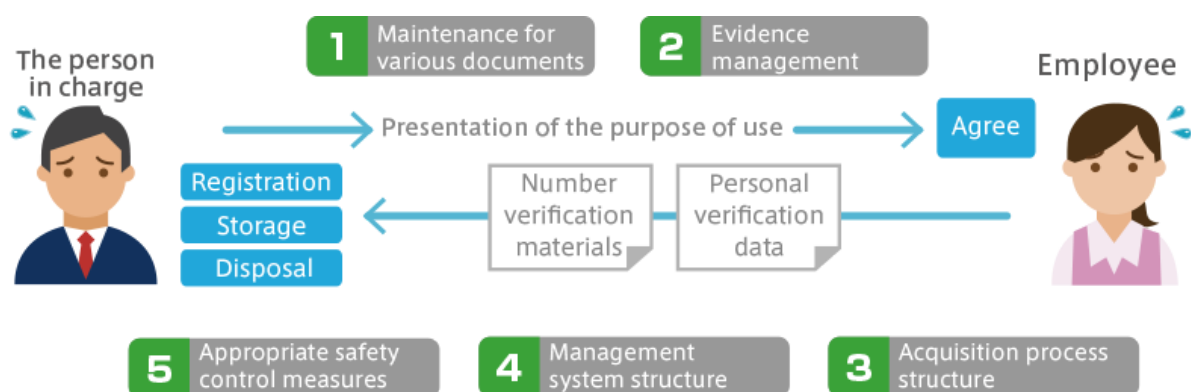
Personal Identification Number Collection: Managing and Agent Service

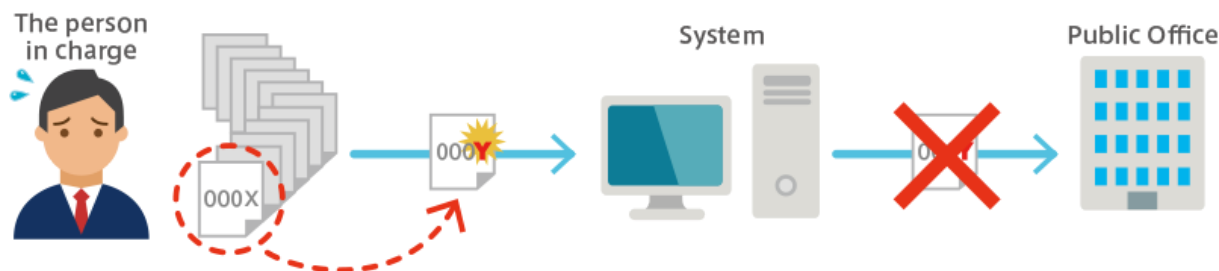


2. You need a collection of dependents' personal identification number

An employee must provide to his employer the dependents' personal identification number.

3. Registration tasks, which need so much accuracy

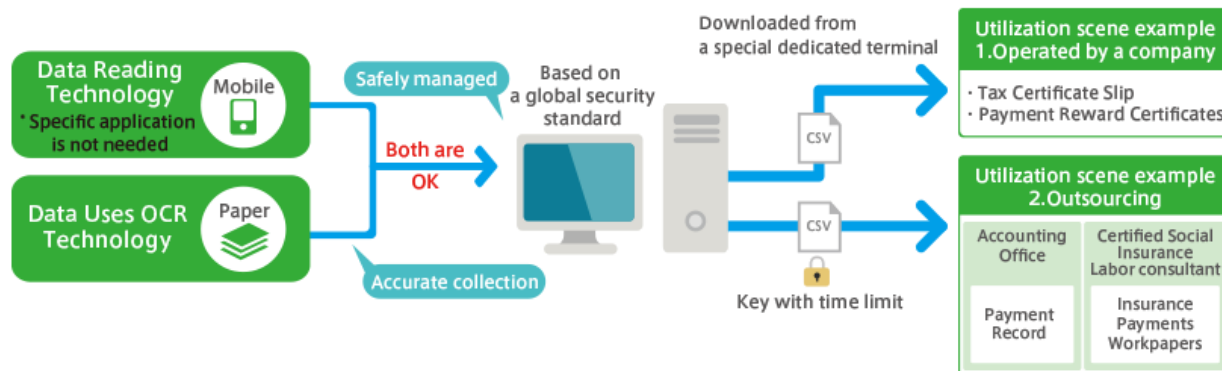
Each person is assigned with a unique personal identification number. Therefore registering inaccurate data will cause errors and mistakes in all sorts of documents which will be processed afterwards.

*Feature phones are not supported.

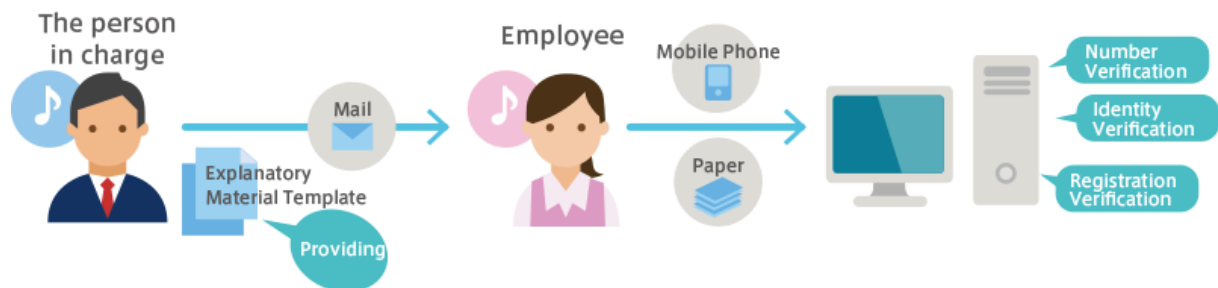
Point 2 : It reduces the amount of work in preparation to deal with the legislative system !

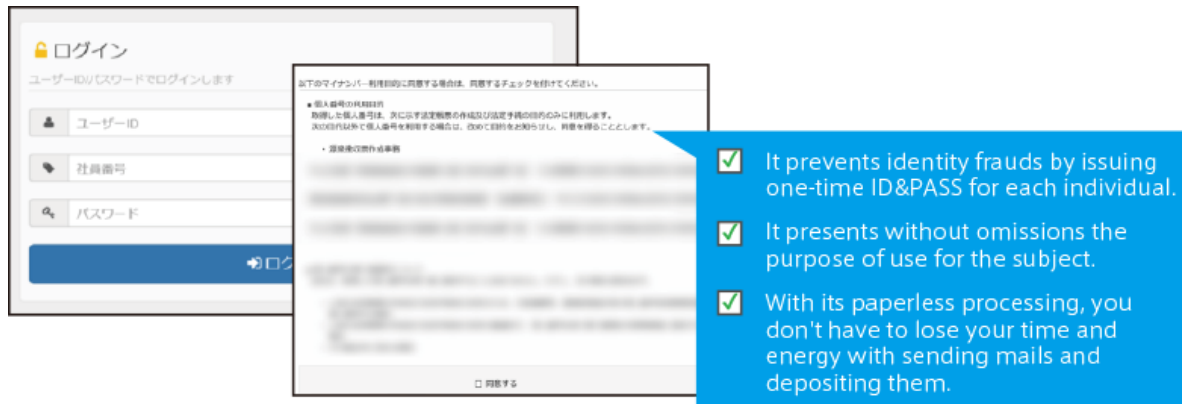

Important Points

- You have to provide information necessary for personal identity number registration, such as employee number, full name, email address and other information about your dependents.

- The personal identity number data can be downloaded in CSV format. It is your own responsibility how you handle this information.

Prices

- Initial installation charge : ¥50,000-¥100,000 / corporate (tax not included) *It differs according to the number of employees
- Collection by smartphones (per one time) : ¥600 / employee + dependents (tax not included)
- Collection by print medium (per one time) : ¥900 / employee + dependents (tax not included) *Special transport costs required, according to delivery method
- Monthly service charge : ¥30,000 / corporations (tax not included) *Special charge will be applied.
- Yearly amount data storage : ¥300 / employee + dependents (tax not included) *It is required every year after the second year if you want to continue the data storing.
