# The Problem/Challenge



- Difficult to discuss three dimensional concepts on 2D screens
- Conference calls are cumbersome and two people can't talk at the same time
- Impossible to share first person view perspective (and hands free)
- No meeting rooms are available slows company progress
- Infrastructure cost associated with number of meeting rooms
- Need for in-person meetings incurs travel and staff cost

# The Solution: HoloMeeting



- Ability to conduct meetings on HoloLens and Immersive Headsets
- 3D audio allows multiple people to talk at the same time (through perception of directional audio)
- Open 61 different file types (e.g. PDF, PNG, Revit, Solidworks, etc.)
- Large models are automatically simplified in the cloud
- Easily view and amend custom 3D models
- Shared gaze trackers allows others to see where the person is looking at

- Time warp: scroll back in time

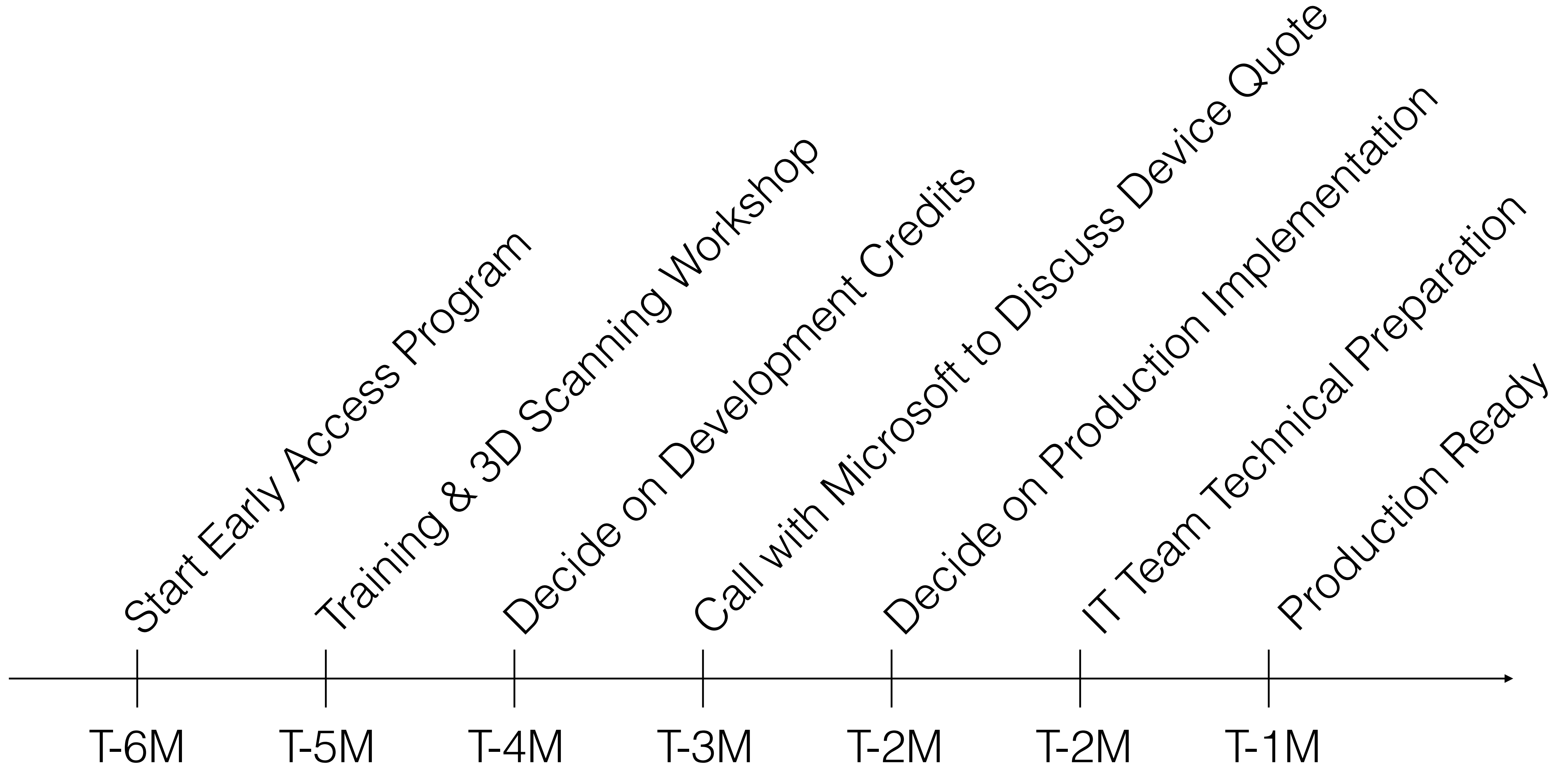

## **What support is included?**

We support you on a fair use basis during standard UK business hours throughout the Early Access Program

## **What happens after the Early Access Program?**

This will depend on your individual requirements since we will be offering the option to host on a shared private cloud, dedicated cloud and on-premise with various model conversion possibilities.

# FAQ (2/2)



## **Can we host the solution on-premise?**

We will be offering this possibility following the Early Access Program to take into account your individual requirements.

## **How many people can participate in a holographic meeting?**

We currently have a limit of 10 participants per meeting. However, we can look into increasing that if required.

## **What are development credits?**

With these credits, you can request particular features. The credits are based on the overall complexity of the feature.

# Terms (1/3)



- By joining the Early Access Program, the Client acquires a license to use HoloMeeting for the duration of the program
- All Intellectual Property Rights in the Platform shall, as between the parties, be the exclusive property of the Provider
- The Client must not sub-license its right to access and use HoloMeeting or allow any unauthorised person to access or use HoloMeeting
- We will protect the Client's Confidential Information against unauthorised disclosure by using the same degree of care as it takes to preserve and safeguard its own confidential information of a similar nature, being at least a reasonable degree of care

# Terms (2/3)



- When data is shared in HoloMeeting, Kazendi may temporarily store these files for the purpose of processing. All files stored on Kazendi servers will be deleted after 30 days of inactivity automatically
- In case payments are late for more than one payment obligation, all claims against the purchaser shall fall due immediately
- Purchase terms of our customers apply only to the extent that they do not contradict our terms of payment and delivery
- We are entitled to assign the claims arising from our business relationship
- The contract is governed by English law



# Terms (3/3)



- The Client hereby acknowledges that this is an Early Access Program and therefore the software is under active development
- Customer Confidential Information may be disclosed by Kazendi to its officers, employees, agents, insurers and professional advisers, provided that the recipient is bound in writing to maintain the confidentiality of the Customer Confidential Information disclosed
- Kazendi's liability in relation to any event or series of related events will not exceed the total amount paid and payable by the Client to the Provider under the Agreement during the 12 month period immediately preceding the event or events giving rise to the claim
- 30 days payment terms
