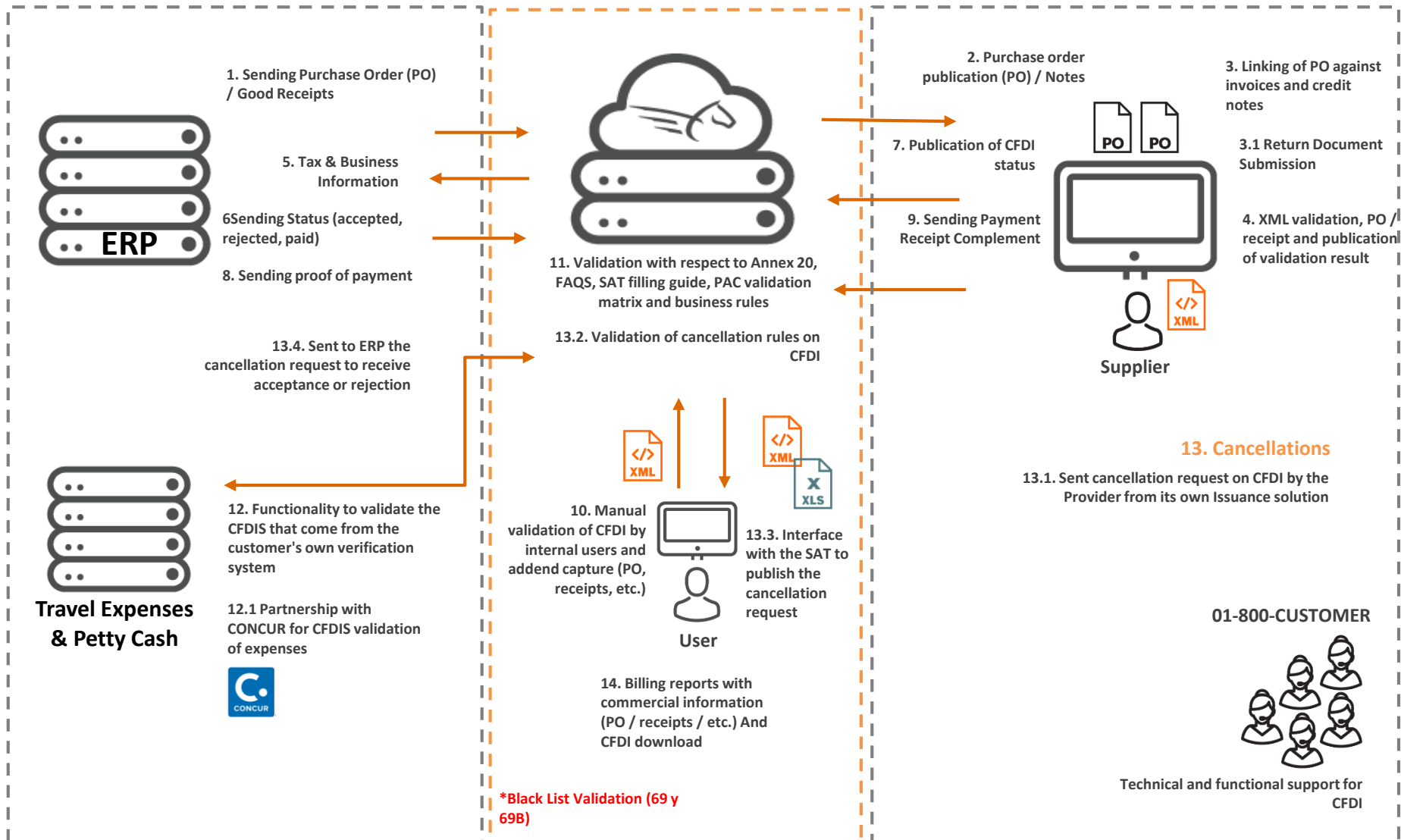

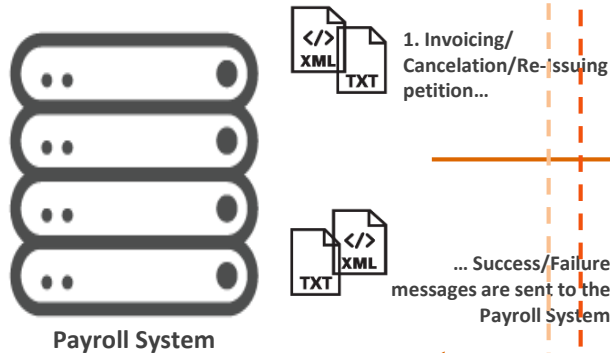

1. Download CFDI from Pegaso Solutions



2. Automatic download of Client's CFDI from FTP (other PACs / systems)



3. Manual load of CFDI of the Client through graphical interface (other PAC / systems)



4. Downloading files from the SAT Portal, which the Client did not have registered in its repositories.
