FINANCE & ACCOUNTING

- Payment notification processing occurs in a manner analogous to bank statements, in order to regulate payments to purchasing associations. "On account" down payments can be balanced with the help of periodical clearing proposals
- Convenient dunning system with online views and calculation of interest as well as output management through own contact information per email, fax, printing (using Transform/Bottomline)
- Payment suggestion through discount window and discount override in secure SEPA direct debit or credit transfer process
- Freely-definable import interface on the surface for filling out daybooks from upstream systems (payroll, tills, etc.)
- Incoming invoice review for volumes, prices, tax situation, summation check level with connection to archive (early and late scanning)
