# **Common Complaints**






- Can't get data out; can't get data to load data warehouse

# The "Software" - ALL IN MICROSOFT S/W



- Data Export
  - D365 F&O Package of 300+ data entities for export to Azure SQL DB
  - Maintained by Armanino for updates to D365 F&O
  - Extendable by client or Armanino
- Data Integration
  - Leverages native SQL Server
  - Integration logic of g/l to sub-ledger
  - Maintained for D365 F&O changes
  - Monitored and supported to ensure data and integration accuracy
  - Extendable by client or Armanino
  - SQL Analysis Services tabular model (client modifiable)

# Buy and Build (not Buy vs Build)



- 30 day implementation of out of the box solution (years of effort)
- Standard Microsoft tools (SQL procedures & SSIS)
- Templates available for client to extend the environment on its own
- Integrate other systems (CRM, legacy, and operational)
- Best of both worlds:
  - Rapid implementation
  - Bl project risk avoidance
  - Ability to extend and add by Armanino or client
