The HMS concept can be divided into two basic models:

In the second model, HMS acts as a Managed Services Provider (MSP). Here the customer does not need his own Microsoft Cloud licenses. HMS provides a Microsoft Azure Cloud Subscription and the customer brings his own SAS license (BYOL). The customer consumes a SAS Software as a Service (SaaS) which is fully managed by HMS. HMS offers tailor-made services from the individual setup of the Azure infrastructure to the installation & monitoring of the SAS application. - Regular "cleanup" of SAS processes: Terminate zombie processes, delete remaining SASWORK folders.
- ✓ regular scanning of SAS server logs for errors
