# What is Whistleblowing



## Origins

The practice of "Whistleblowing" stems from financial scandals in the United States and Great Britain, which have had global repercussions and echoes.

It is currently a widespread practice in the Anglo-Saxon world, where it is regulated by specific regulations.

Italy is tackling this issue for the first time through the Anti-Corruption Law 190/2012, which introduces whistleblowing as one of the measures to prevent and combat corruption



## Procedure

Whistleblowing is a procedure that allows you to report, confidentially or by name, any crimes, frauds and activities that violate current regulations and codes of ethics / conduct adopted by organizations, both public and private, facilitating the activation of adequate investigation, remediation and mitigation actions.

# Obstacles to the adoption of Whistleblowing systems



## Issues

The main criticalities relating to the adoption of organizational models and/or tools to support the correct management of the company derive from:

- the difficulty of adequately raising the awareness of the staff involved
- the high cost of implementing and managing the models/instruments
- the limited capacity of the current models/tools to detect illicit activities beforehand

# Our Whistleblowing solution



## WB Confidential

WB Confidential is the web-based application for the management of confidential and anonymous reports within the Whistleblowing process.

The application allows the management of bidirectional interaction flows between the structure of management of reports and the whistleblower, with the possibility of extracting highly customizable reports.

WB Confidential presents itself to users as a Portal divided into:

- ✓ a public area, freely navigable by stakeholders, within which it is possible to acquire information on the practice of Whistleblowing, on the service and on all the information that the organization intends to transfer to users
- ✓ an area subject to authentication for sending and monitoring reports sent by stakeholders

the structure of the Portal in a public and a reserved area has been specifically designed to introduce the user to the practice of Whistleblowing in a progressive way and to ensure him about the confidentiality and seriousness of the service offered. The graphic layout of the Portal has been defined with the same objective, it can be customized to re-propose the colors and image standard of the organization.

The internal control structure has the power to investigate the problem through further information requests to the reporter

The internal control structure carries out a final evaluation of the report

The internal control structure communicates the outcome of the evaluation to the organisation

The organization periodically monitors the most frequent trends and cases of reporting

The whistleblower receives an identifier for confidential dialogue and reports an irregularity or misdemeanor

The reporter responds to questions and has the possibility to attach documents or evidence

The investigation process is carried out and the internal control structure evaluates the actual results as well as the evidence

The organisation takes corrective action and applies sanctions as per the disciplinary system

## For the organization

in the public area of the platform is available a large section the organization can customize in terms of content and messages



## For the employees

Is available a large section in the public area of the portal where the service and the procedure for accessing the Message Board to communicate confidentially with the structure of management of reports is illustrated.



## For the internal control structure

The reporting management structure has a back-end investigation and reporting tool organized by subject, area of interest, status, etc.. Other reporting sources (e-mails, faxes, letters, phone calls, etc.) can be integrated into the document repository.



## For the stakeholders and outsiders

Is available always up-to-date information on the service and on the regulations in force regarding the management of reports (in the case of a service open to all stakeholders)

Reports are filtered, verified and managed by the reporting management structure, which will enable the organization to intervene promptly with respect to irregularities that have emerged.
