eSign ePDF for Microsoft Dynamics 365 Business Central is the solution that will enable you to digitally sign your PDF documents, such as invoices or credit memos, among many others.



Using eSign ePDF, you will be able to send your digitally signed PDF invoices to your customers. Just using a valid digital certificate from any authorised organism, you will be able to send your digitally signed PDF documents.

Additionally, eSign ePDF will enable you to digitally sign any PDF report from Microsoft Dynamics 365 Business Central. From invoices, to contracts, budgets, payrolls, etc. Any PDF document will be digitally signed with eSign ePDF.



You will be able to work completely within your Microsoft Dynamics 365 Business Central, and you will also have an online archive of your signed PDF documents at the eSign Portal, INNOVAONLINE.

Moreover, at the INNOVAONLINE portal, you will have the chance to send your PDF documents for shared signature with a third party (or parties) just using their email. This additional functionality will allow you to fully optimise the eSign ePDF potential.
