

What does the new ruling require?

On March 9, 2020, United States Department of Health and Human Services (HHS) Centers for Medicare and Medicaid Services (CMS) and Office of the National Coordinator for Health Information Technology (ONC) released the final Interoperability and Patient Access Rule, forcing healthcare institutions to adopt modern technologies to deliver enhanced care coordination.

CMS is modified the Conditions of Participation (CoPs) to require hospitals, including psychiatric hospitals and CAHs, to adopt modern enabling technologies to share data from major patient events such as admission, discharge, and transfer with community providers and post-acute care teams. To maintain Medicare eligibility, the CMS rule states that providers are required to comply with the new rules within twelve months.
