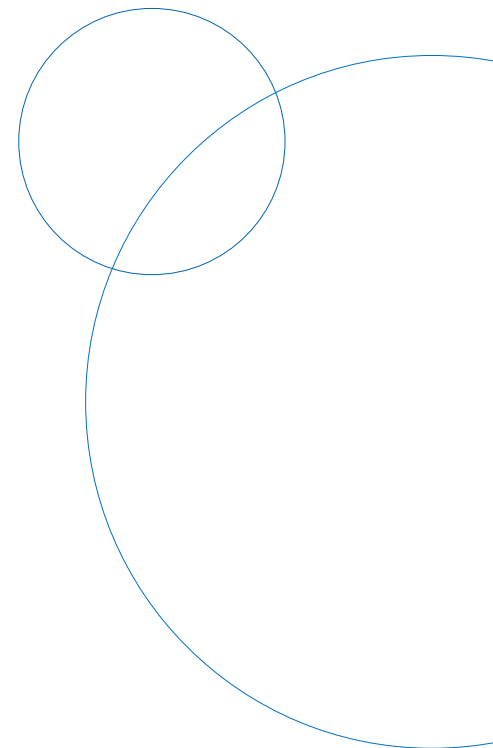




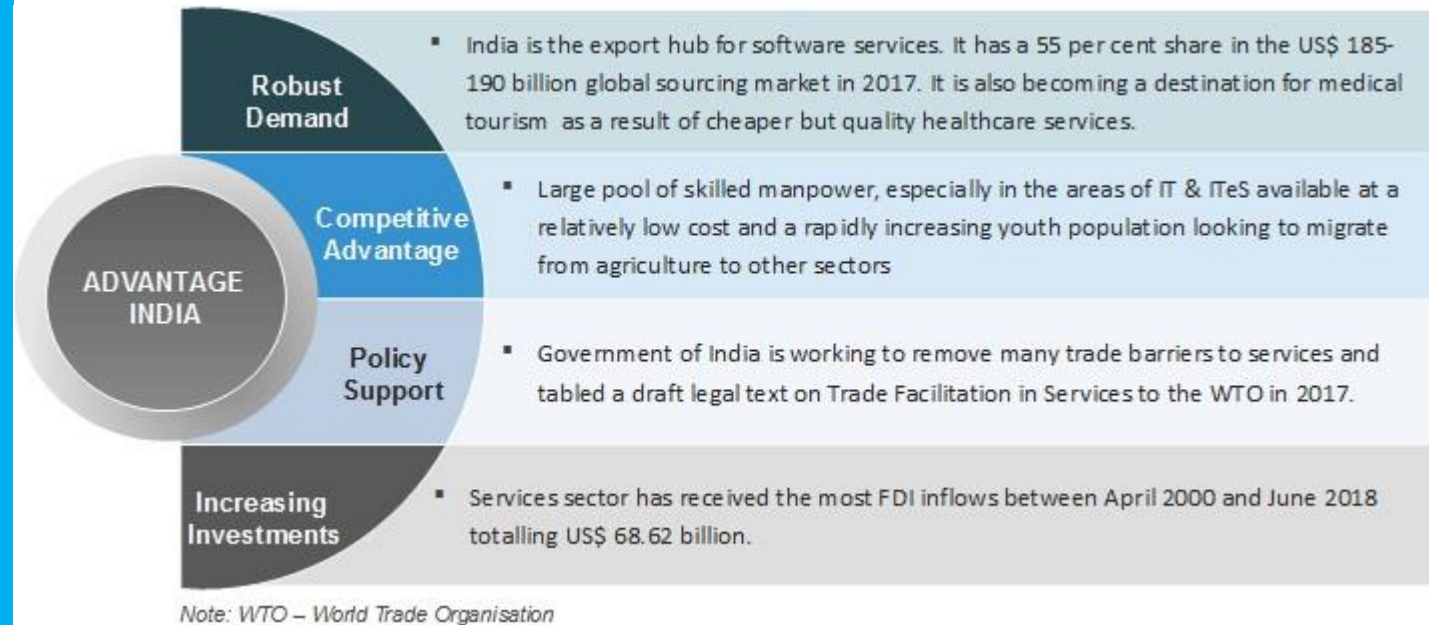

- End-to-end tracking for future orientation



How EXIM for Service Industry works?

- 1. E-BRC details:** The prima facie requirement for any export benefit availment.
- 2. SEIS transaction Journal:** Once entire shipping bill addressed with E-BRCs, now entity shall create SEIS journals to verify the status of available SEIS benefit in specified time
- 3. SEIS Scheme:** In next step, all SEIS applied licenses with DGFT will listed in "SEIS Scheme" form with latest updated status.

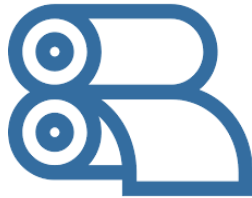
