




In the Philippines, corporations and persons engaged in business maybe required by the Bureau of Internal Revenue (BIR) to withhold taxes on payments or income. Withholding tax is an effective tool used by the government to collect taxes. It encourages compliance from the tax payers and reduces collection effort from the government.



## Who are Required to Withhold Taxes?





- Individuals engaged in business or practice of profession
- Non-individuals (corporations, associations, partnership, cooperatives) whether engaged in business or not
- Government agencies and its instrumentalities (National Government Agencies (NGAs), Governmentowned or Controlled Corporations (GOCCs), Local Government Units including Barangays (LGUs)
- \* Mandatory withholding of top withholding agents:
  - Top 20,000 private corporations
  - Top 5,000 individual taxpayers
  - Medium Taxpayers, and those under the Taxpayer Account Management Program (TAMP).

Creditable withholding tax - tax which is withheld by the buyer/withholding agent from his payment to the seller for the sale of the seller's ordinary asset/services, and which tax is creditable against the income tax payable of the seller.

**Expanded** - a kind of withholding tax which is prescribed on certain income payments & is creditable against the income tax due of the payee for the taxable quarter/year in which the income was earned.

**Final Withholding Tax** - a kind of withholding tax which is prescribed on certain income payments & is not creditable against the income tax due of the payee on other income subject to regular rates of tax for the taxable year.



#### BIR Form 2307

 BIR Form 2307 - Certificate of Creditable Tax Withheld At Source

#### Issuance:

For VAT Withholding - on or before the 10th day of the month following the month in which withholding was made.

For EWT - on or before the 20th day of the month following the close of the taxable quarter.
