EASIER COLLECTION OF PAYMENTS

This extension adds another collection functionality to your finance system, enabling your customers to pay directly via their smartphone with a single swipe. Send the invoice directly to your customer and let your customer pay with a single swipe.





TRANSPARENT PAYMENT STATUS

You can track the payment status at any time. This way, you can see if the payment has been approved, paid or rejected, or if the due date has been passed.

ONE-SWIPE-PAYMENT

This extension is easy and swift to install in Microsoft Dynamics 365 Business Central. The setup can be done in 5 minutes, and you can start to send invoices in two ways;



MOBILEPAY INVOICEDIRECT

Once you have installed the MobilePay extension and create an invoice, you can select the MPI DIRECT payment method. Upon posting the invoice, your customer (who must be a MobilePay user) receives a message on his smartphone stating that there is an invoice for payment in MobilePay. The customer opens MobilePay and approves the payment with a swipe.

ONE-SWIPE-PAYMENT

This extension is easy and swift to install in Microsoft Dynamics 365 Business Central. The setup can be done in 5 minutes, and you can start to send invoices in two ways;



MOBILEPAY INVOICELINK

You can also insert a MobilePay payment link on your invoices. Upon posting the invoice, your customer receives the invoice as usual – but with a MobilePay payment link inserted. When the customer clicks on the link, the invoice opens in MobilePay and the customer approves the payment with a swipe. MobilePay Invoice Link allows you to offer your customers payment via MobilePay even if you do not have the customer's mobile number. The only thing this solution requires is that you send the invoice electronically to the customer, for example as PDF.
