This is error-prone and relies heavily on manual validation and witnessing to ensure compliance. In addition, there is no visibility of stock levels across the organisation to ensure that locations hold adequate stock at all times and the replenishment of stock often requires extra effort.

eCDR Pro is an electronic Controlled Drugs System that has been specifically co-designed with an NHS Trust to help Clinical Directors & Chief Pharmacists to manage CDs more effectively across an acute setting.

The system is implemented on Microsoft's Azure Cloud platform and can be scaled to support 100s of CD storage cabinets, with 1000s users and flexible to meet the needs of future Integrated Care Systems.

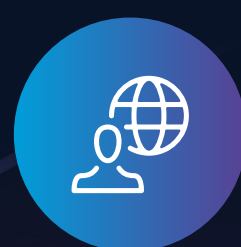
