


### **Simplified Classification & Taxonomy Management**

- Single Interface Management Streamline the classification and file plan process with a single interface that allows Records Managers to configure and manage a classification scheme or file plan and apply retention and disposal rules.
- Rule Application The Records Manager can apply
  multiple rules directly to single classification terms, while
  also applying retirement settings that dictate the life of
  the term.
- Manual or Automatic Configuration User input can be configured to be as manual or automatic as your organization requires.
- Business Classification Management Without switching between multiple windows, you can create business classification terms, import terms and retention and disposal rules, associate business classification terms with rules, and synchronize business classification terms—all-in-one place.
- Maximize Productivity Easily link business rules to file plan terms, view all records environments, apply settings, and assign content to business owners through a single pane of glass.




Management from a single interface

- Unique Identifiers The Records Manager can configure unique identifiers for content across any site collection and according to a predefined pattern. The document or record is assigned the unique ID when it is created or captured – no end user input required.
- Global Search Use metadata to help quickly locate the records you need, applying Boolean operators and up to 10 criteria fields including name, format, type, and classification. Take action right from the search results to manage disposal holds, reclassify documents, declare content as a record, and more.
- Automatic Classification Configure metadata-based auto classification rules to apply file plan terms or classification to content in Microsoft 365, Exchange Online, SharePoint on-premises, and file shares.




Emails with applied terms

#### **Intuitive Retention & Disposal Rules**

- Information Lifecycle Management Seamlessly allow your Records Manager to build business rules that can manage any stage of your information lifecycle.
- Disposal Holds Prevent future disposal of content with a disposal hold, so users can safely access, edit and utilize content knowing a disposal action will not occur until the hold's been lifted.
- Flexible Rules Build flexible business rules that can determine lifecycle outcomes for your content by creating action- or date-based triggers, and using any metadata captured against an object as criteria for the rule.
- Manual or Automatic Rules These rules can be completely automated (without user intervention) or run with manual approval from a record owner.
- Multi-stage Manual Approval Process Utilize a manual approval process (up to five steps) with a drag-and-drop workflow builder for record disposal approval. Flexibly extend disposal time and easily reassign the reviewer if the approver was assigned in error.




Disposal Action Activity Management

- Content Lifecycle Settings Create, edit, or delete rules to decide whether to retain, remove, archive, destroy, or export current content.
- Content Repository Management Apply information management policies to Microsoft 365 content,
   Exchange Online, and File Shares, regardless of format, from the time of creation through decisions on retention, disposal, or transfer.
- Records for Review Records Managers can build a
  multi-stage approval workflow (up to 5 steps) for
  managing disposal approvals, using a visual workflow
  builder. Business owners can approve or reject disposal
  actions with full decision history kept as part of audit
  trails to support defensible disposal processes.
- Related Records Relate and manage items together whether electronic or physical, choosing to destroy the related record with its parent or separate them to be managed as single items.






#### **Smart Auditing & Reporting**

- Report Center Configure, view, and download reports, and gain a comprehensive understanding of how information is being managed in your electronic and physical environment.
- **Records Management Dashboard** Display visual reports on a graphical dashboard to allow Records Managers to view details of the number of items being managed by the system, what's been destroyed, who has outstanding approval tasks, and more.



Records Management Dashboard

- Information Management Use reports to proactively manage your information outcomes and report on all actions performed on items or by a user.
- Administrator Audit Reporting Out-of-the-box audit reporting solution displays detailed information of activities, including operation records and export records, performed in Cloud Records within a specific timeframe.
- Action Management Access multiple reports to manage upcoming disposal actions, and interrogate actions performed on an item or by a user.




Rule Usage Report

## **Physical Records Management**

- All-in-One Records Management Manage physical items, including cabinets, boxes, folders, and records, using the same classification scheme and business rules.
- Template Management Create different physical templates and template suites for boxes or folders, assigning or inheriting metadata to each.
- For End Users Create requests for the loan of physical folders or boxes as well as request the creation of new physical items triggering an approval workflow to the records management for oversight and review.




- For Records Managers Physical records explorer gives full oversight of what's happening in the physical world including creation, movement and tracking of all physical information across the organization.
- Access Control Apply access controls to physical records for enhanced security.
- Space Management Easily perform simple space management activities using the reporting that comes with physical records.

Physical records explorer


- AvePoint Records Mobile App Scan Cloud Records physical barcodes via the AvePoint Records mobile app to perform actions in bulk, such as moving or updating item status.

## **Centralized Management & Security**

- **Delegated Access** Delegate permissions to defined groups or users, allowing management of the content repositories according to different business requirements.
- Security-Trimming Restrict search results and reporting based on previously configured security groups.
- Physical Records Access Control Determine what actions end users can perform on all physical records and place access controls on specific physical locations to restrict access at both location and physical item levels.
