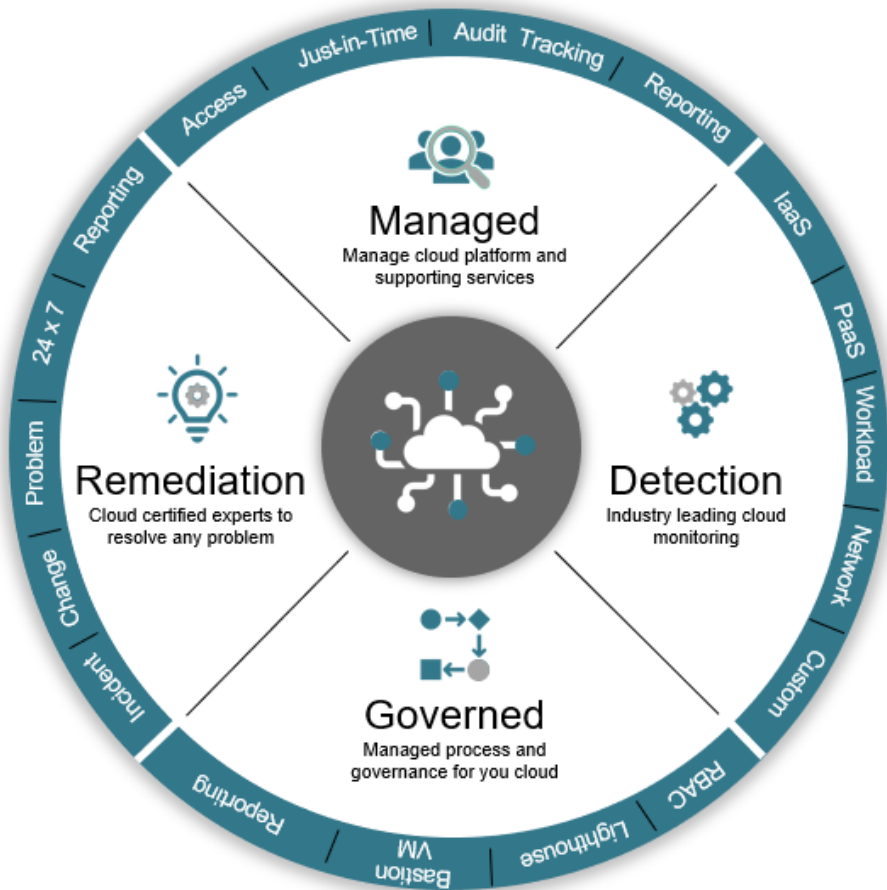

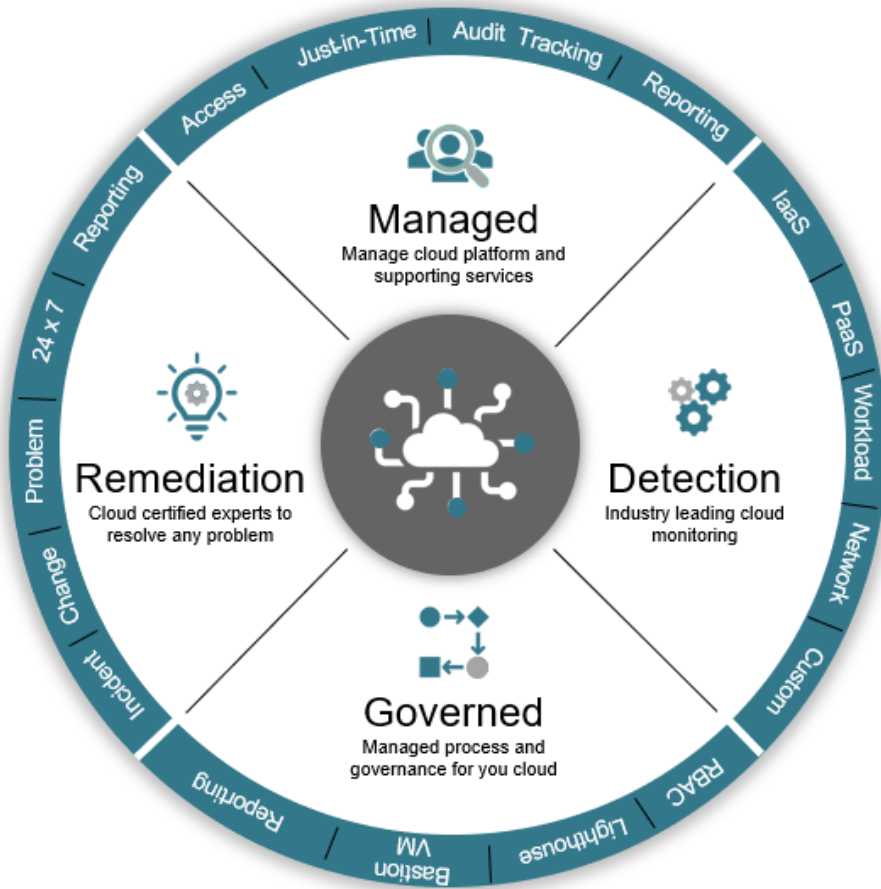

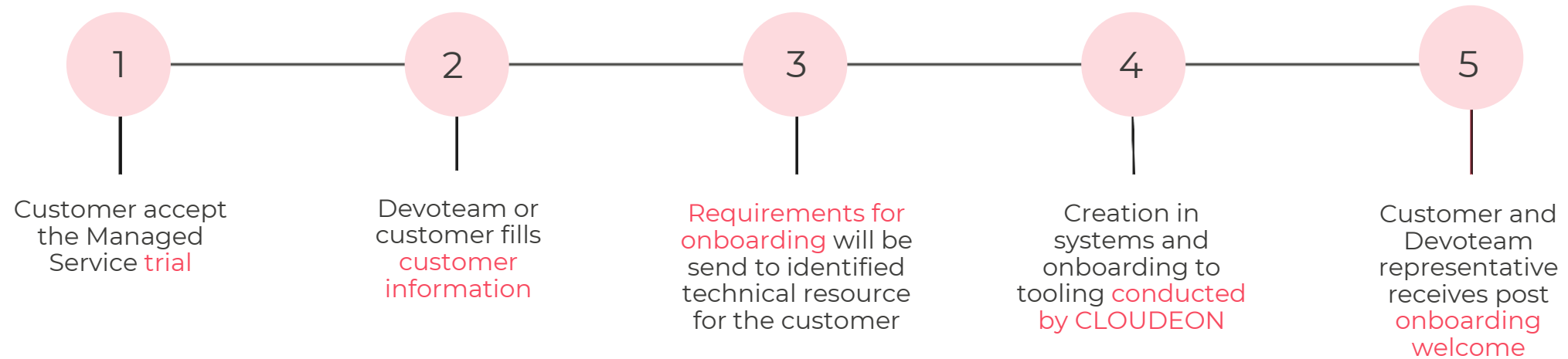
What is Managed FinOps

Sign-up process



*** The trial will run for 3-months for free across both FinOps and Managed Platform. The customer can choose to continue the trial to a full Managed FinOps and Managed Cloud Platform at any point during the trial.

Terms & Conditions

- The trial of the Managed Cloud Platform is not covered by the typical SLA/SLO for the digital estate during the trial period, regular SLA/SLO is set post trial.
- The FinOps implementation is conducted across the tenant level of customers onboarding to the trial version.
- The trial across FinOps and Cloud Platform both end on April 29th
- The customer must have begun their trial prior to December 31st
- The trial does not have management fee for Devoteam during the trial, some minor costs can be attributed to the customers cloud environment during the trial. These are not covered by Devoteam.
- The managed service provider provides access to the FinOps platform and limited support for additional questions / configuration of specific reporting within the tool during the trial.
- The trial covers both FinOps and Managed Platform as one combined offering, and both must be onboarded for this trial.
- Following the trial all information related to the customer will be removed from Devoteam and CLOUDEON systems as it related to the trial if the customer does not choose to continue with the full managed service.

FAQ

What happens after the trial? - You can choose to continue using the service as a managed offering from Devoteam or the trial will end with no associated cost.

What if I want to continue the service after the trial period? - We will create a Managed service agreement with you that fits your specific needs.

What if I want to expand the number of subscriptions covered by the service? - The trial does not limit the number of subscriptions you can add to your trial.

What is the cost of the services? - The trial is free for you as a customer. If you wish to continue with the managed service after the trial, a managed services fee will be implemented.

What about security? - We are used to working with financial services, energy providers and high security organizations. All our managed services are compliant with global standards for security and management thereof.

Who do I communicate with? - A designated contact will be appointed during the trial for questions related to the trial.

Where can I find the detailed service description of services provided? - The FinOps and Managed Platform has extensive descriptions that can be provided on request.

How much time would I spend on the sign-up process? - It should not require more than 30-60 minutes of time in your organization.
