
Participants of the session (excluding government personnel) can register onto the web portal for virtual hearings by entering relevant details. This will then be cross-verified with the organization database.



An automated email is triggered to participants when a new court hearing is scheduled for a registered case.




An automated email is triggered to participants prior to the court hearing to ensure all users have been successfully on-boarded to the platform.





Virtual court hearing session with Judge




Once all participants and government personnel have joined the session. The judge can commence the session.
