



A landing zone is the basic building block of any cloud adoption environment, providing an accelerator to deploy a best-practice Azure environment. Ensuring the basics such as Management Groups, Subscription Structure & RBAC are configured correctly at the start prevents time-consuming changes in the future.

Governance guardrails such as policies, locks, cost management & logging can prevent expensive mistakes & inconsistencies between projects. Enterprise tooling such as Sentinel, Monitoring & specialized blueprints will provide visibility of performance & compliance across projects.





The EA Enrollment covers the Azure usage possibility for the subscriptions. (so you are able to start using Azure services without any additional documentation. (except the purchase order...)

Option A)

The subsidiary is committed to a yearly consumption. The Azure prepayment will be available till the Anniversary date of the agreement (January 31). (the amount that you haven't used during the period, will be lost...)

Option B)

The subsidiary can purchase Azure prepayment anytime, the amount of the Azure payment will be available till the end of the EA Agreement (January 31, 2023).




Azure PrePayment

The Azure Prepayment calculation can be complicated, but here is the calculation method for the better understanding:

Option A) – committed yearly consumption

No. of months: 12

Unit price: 84,33 € (minimum monthly commitment)

The amount of the Azure Prepayment must be divisible by $(12 \times 84,33)$.

```
E.g.: 10000 € PrePayment will be rounded to 10119,60 €
```

Option B) – ad-hoc prepayment

No. of months: (activation date - 2023.01.31)Unit price: 84,33 € (minimum monthly commitment)

The amount of the Azure Prepayment must be divisible by (no. of months x 84,33). E.g.: 20000 € PrePayment will be rounded to

20 239,20 € if the activation date is 2021.06.01.
