SIGNATURE

It adjusts to multiple types of signature for the different hierarchies of documents:
Import of signed documents,
Simple electronic signature,

SIMPLE, MODULAR AND REUSABLE

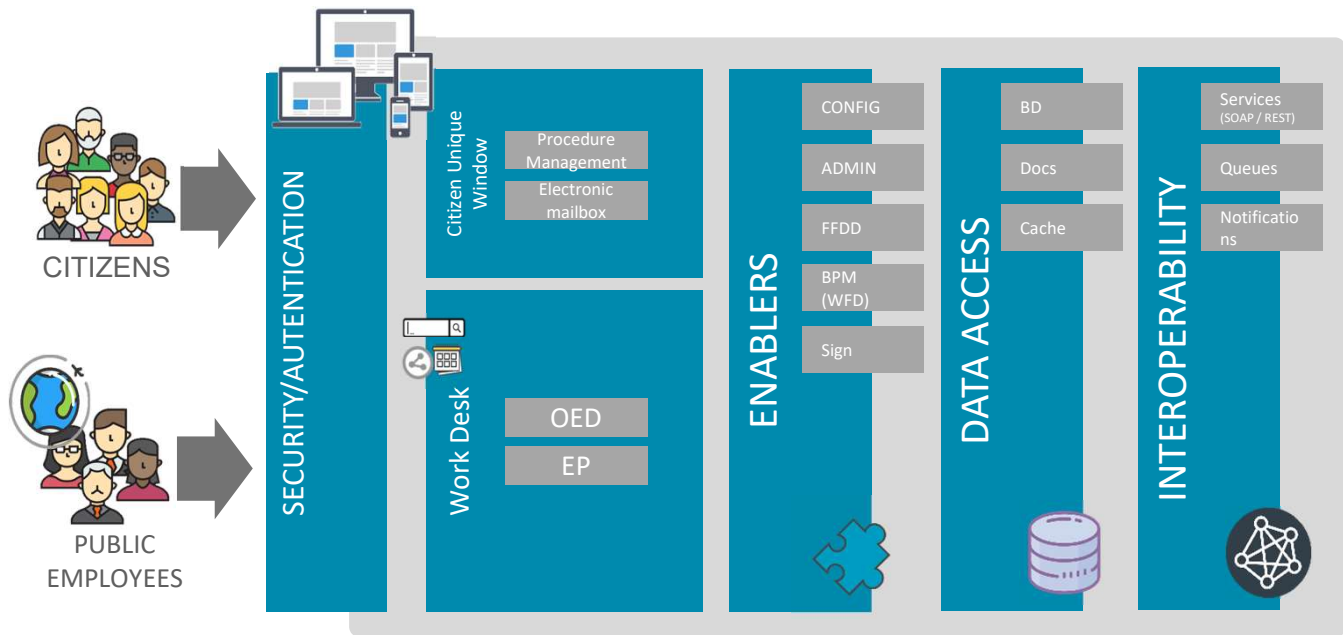
Following the concept of decomposition where each component performs simple functions and can be extended or exchanged by pre-existing modules in the organization.

The **Work Desk (WD)** is the access portal for the administration employees from you can have a comprehensive view of your tasks - produces, reviews and sign official documents from the **Official Electronic Documents (OED)** module or process files by linking documents, making passes from the **Electronic Processing** module (**EP**)
