Starting October 1, 2016 all VAT-registered taxable persons – including foreign companies registered for VAT – are required to submit a SAF-T file in XML format to the Tax authorities on a monthly basis.

Split-Payment regulations:

The Act of November 9, 2017 amending the Act on Value Added Tax.

The use of split payment mechanism divides the gross amount of payment into two payment streams.

The net amount will be transferred to the seller's bank account, while the tax amount is transferred by the bank directly to a special bank account, the so-called VAT account.

Taxpayers Whitelist regulations:

Introduced in 2019 so called "White list of VAT taxpayers" include, among others, bank account numbers of VAT taxpayers. If payments is made to an account other than the one indicated in the list, such expense will not be treated as tax deductible. Additionally, joint liability for VAT obligations of supplier will be considered.
