Error Codes

Landed Cost API uses standard HTTP response codes to indicate the success or failure of an API request. In general: Codes in the 2xx range indicate success. Codes in the 4xx range indicate a client side error, which means that API request has failed given the information

provided (e.g., a missing parameter, invalid value passed etc.). Codes in the 5xx range indicate an error with API's servers (normally this shouldn't happen at all).

If the response code is not 200, it means the API request has failed and you may need to take action as per the error code. You can check the response (which will be in JSON format) for a field called 'message' that briefly explains the error.
