
Workstream

Outcomes

1	Discovery & Design	Discovery and analysis of data in a client M365 tenant, identification and interview of priority stakeholders, development of data security requirement definitions, and develop data security control design specifications.
2	Data Classification	Delivery of an initial configuration in production for data classification requirements for classifying sensitive data at rest in the M365 cloud
3	M365 and Endpoint DLP	Delivery of an initial configuration in production for data loss prevention of data in motion in the M365 cloud and managed endpoints
4	(Optional) MDCA Detection	Delivery of an initial configuration in production for preventing data loss of sensitive content in non-Microsoft cloud storage locations
5	(Optional) Data Classification On-premises	A deployment of AIP Unified Scanning for on-prem content stores and configuring client-side labeling with O365 apps.
6	Monitoring and Support	Monitor and produce data risk analytics by content sensitivity, activity, and traffic. Define an M365 Data Security Operations plan for ongoing tuning and response workflows


