





STEP 1A

Document creation in the ERP and real-time (online) transfer to IMPACT myData Agent the following:

- → Data according to National Standard Format for the Electronic Invoice
- → Data according to the Invoice Synopsis

The transmission process can be operated via:

- REST API ERP calling myData Agent
- File transfer

STEP 1B

Simultaneous creation and transmission of PDF file. Alternatively, creation of PDF file from the Archiving application

STEP 2

IMPACT myData Agent checks compliance of mandatory fields according to the National Standard Format na the Invoice Summary (synopsis) and creates:

- The Electronic Invoice file according to National Standard Format
 (EN 16931- PEPPOL CIUS)
- Invoice Summary (synopsis)

In case of error, it sends a notification message to the relevant user of the issuer

STEP 3

IMPACT myDATA Connect service receives the files, identifies the Invoice Issuer, and checks the accuracy of the data received, based on IAPR (AADE) rules. In case of errors, these will appear on a special page of the myDATA Connect service and an automated email will be sent to the relevant user of the issuer.

Then, **IMPACT myDATA Connect service sends, in** real-time, on to the myDATA platform of the IAPR **the Summary of the Document**, an encrypted communication channel.


STEP 4

IMPACT myDATA Connect service receives from myDATA platform of IAPR (AADE) reply message including the following:

- The Unique Registration Number (M.AP.K.) and the status update of the application
- Document Authentication String
- Unique Invoice Hash Value

And performs the following tasks:

- Creates a QR code with the invoice information and add this to the PDF file
- Saves the Electronic Invoice according to the National Standard Format, the Invoice Synopsis, and the PDF file






STEP 5

IMPACT myData Connect sends the following information that comprise the "myDATA Set" back to myData Agent:

- The Electronic Invoice, according to the National Standard Format
- The Invoice Synopsis
- The PDF file with the QR code
- The Unique Registration Number (MARK)
- The Authentication String
- The unique ID
- The myDATA platform update status









STEP 6A

IMPACT myData Agent automatically sends over to the Archiving application, the complete "myDATA Set", where the PDF file with the invoice metadata is archived and the following information is attached:

- The Electronic Invoice, according to the National Standard Format
- The Invoice Synopsis
- The Unique Registration Number (MARK)
- The Authentication String
- The unique ID
- The myDATA platform update status

STEP 6B

At the same time, **IMPACT myData Agent promotes the following to the ERP system:**:

- The Unique Posting Number (M.A.R. K.)
- The Authentication String
- The unique ID
- myDATA application update status

STEP 7

For those customers/recipients that are set for electronic transmission (e-invoicing), the Archiving application contacts the **Paperless**Connect service and sends the PDF invoice file along with "myDATA Set"






The Paperless Connect service sends an e-mail notification to the end customer/recipient in order to receive the Electronic Invoice with the "myDATA Set"



STEP 1


The Invoice issuer sends the summary to myDATA platform and updates both the Issuers' as well as the Recipients' e-book (myDATA records)

STEP 3B

Results Classification:

- Documents fully matched
- Synopsis that cannot be associated with an Accounting entry
- Accounting entries that cannot be associated with a Synopsis




STEP 4

myData Connect transmits to myDATA platform:

- The expenses category classification for fully matched documents
- The Invoice Synopsis with the expenses category classification for the entries that cannot be associated with a Synopsis (e.g. accounting documents whose issuers are not obliged for reporting to myDATA)









myData Connect service receives in real-time a response message from the IAPR myDATA platform, including the update status of IAPR myDATA platform and the Unique Registration Number (MARK.)

STEP 5B

myDATA Connect SERVICE sends, in real-time (online), to myData Agent the Unique Registration Number (MARK)tov M.AP.K. and the status


















STEP 6 Optional
