The EDM Council is a collaborative professional organization with 300+ member-firms, with the core mission to lead best practices for data management. They created the CDMC Framework, one of several frameworks released by EDMC, used to assess cloud data management for businesses or cloud providers, focusing on transparency & responsible data practices, focusing on 6 components:

Governance & Accountability

Ensure clear governance, accountability & controls for data

Cataloging & Classification

Know what data is in the cloud and how sensitive it is

Accessibility & Usage

Automating control of access & use of data

Or a certification assessment can be leveraged by a consumer or cloud provider that would like to receive a certification for their cloud data capabilities.



Pair with an existing Avanade accelerator

The components and controls laid out by the CDMC framework can inform data architects and engineers on best practices for conducting a solution. Certain aspects of CDMC can also be embedded in a solution (ex: key metrics on data security). A few solutions CDMC assessments can be paired with:

- Rapid Deployment Framework (RDF)
- Metadata-driven Data Management Framework (MDMF)
- Microsoft Modern Analytics and Governance at Scale
- Microsoft Purview implementation



Assessment-only (standalone)


An assessment can be purchased as a standalone offering from Avanade, without the requirement of adding on to any solution. Below are the different assessments which could be purchased:

- Readiness Assessment (consumer): Have your business's cloud data landscape reviewed against the CDMC framework with a scored assessment to inform a remediation plan
- Certification Assessment (consumer): Independent certification that cloud data management capabilities are achieved and can be evidenced, leading to a digital badge being awarded by the EDM council
- Certification Assessment (provider): Specification of tests for cloud providers that prove existence of key controls for managing data risk of sensitive data in the cloud, leading to a digital badge being awarded by the EDM council



Engagement Approach

Example timeline only. Timing, activities and milestones vary by assessment type and complexity.



- 1. Environment is ready to be assessed access can be granted to evaluators
- 2. Evaluators will produce documentation. For client use only (not to be submitted to council)
- 3. Post final reviews, evidence in milestone 2 will be delivered to the client
- 4. Assuming a pass, Avanade will complete a certification form and provide it to the client, with instructions to submit a second form to the council, assuming a certification is desired
- 5. If relevant, the EDMC will provide a digital badge for the client


