## ConnectHub Key Features – For FIPs


- Implements the FIP API specifications of the AA ecosystem
- Capability to support multiple AA and hence is fully interoperable in the AA ecosystem.
- In Built Security module to Encrypt the financial information
- Provides an Admin UI with below features
  - Monitor & Search the Customer data requests, consents, etc.
  - Setup of FIP module and AA registration (capability to integrate with Central Registry)
  - Dashboard providing stats on Customer adoption, Aggregator adoption
  - Setting up of roles, users for the ConnectHub Admin operational users.
  - Role based access to the ConnectHub Admin UI. (e.g. Admin Role, View Role).
  - 4 eye check (Maker / Approver) for key admin operations for setting up ConnectHub FIP.
- Consent Management features
  - Validation and verification of consent prior to honouring FI data requests.
  - Search consents through the Admin UI
- · Logging of all API requests and audit of Admin UI activities.
- Provides an EAI Integration framework to integrate with FIP source systems.
- In Built integration with SMS communication channel for OTP based authentication (Using 2Factor.in) or can be easily extended to integrate with other SMS delivery providers.




