- Finalize migration plan
- Migration and mail routing cutover event
- Post migration data validation and support
- Post migration Microsoft-led user training for products



PHASE 5: PROJECT COMPLETION

- MyDaymark Support Portal onboarding
- Final high level knowledge transfer review (knowledge transfer occurs throughout the project phases)
