



Managing Information in Microsoft 365

The <u>M365 Information Governance suite</u> is the latest set of features to simplify information management and compliance responsibilities. Few enterprises found SharePoint on-premises good enough for managing corporate records, but this has changed with Microsoft 365 (M365). The key to managing governance and compliance in M365 is not SharePoint Online, but E5 Microsoft information governance to simplify and automate records management with record labels and label policies.

Once you integrate Microsoft Information Governance with M365 architecture, you transform M365 into a secure and compliant platform for digital transformation. Information is managed within the platform, and apps can be built or bought on top of the platform to meet specific business needs. M365 governance suite can also manage content from 3rd party solutions including SAP, Oracle, and ServiceNow. The consequence is better connected people, information, and knowledge with inherent and transparent security and compliance. The M365 Information Governance features will make it easier to find and manage information.




Microsoft 365 Reference Architecture

Infotechtion has already implemented Microsoft 365 integrated with governance features at several large and highly regulated companies. There are many ways of configuring it, but often it includes establishing an integrated architecture for M365 workspaces (Teams, SharePoint etc.) that are newly created and then apply the integrated architecture retrospectively to pre-existing workspaces.

An integrated architecture is a critical success factor, this includes key fundamental principles focused on simplifying your user experience with automation and without compromising compliance, legal and regulatory requirements. An example of key architectural activity would be to outline the role of site provisioning services and metadata model for both new and existing site collections.

Information architecture informed by compliance, business and in-depth product knowledge can lead to various benefits. As an example, Infotechtion approach focusses on importance of automated metadata application, to ensure all information receives default metadata and governance policies instead of overheads for users to take the right actions. As a result, users experience improved search, - through Microsoft 365 search – or use progressive refiners - to find information per business area, location, process, etc. We also simplify and automate records management based on content and metadata.

The above approach is also pivotal to development of cost efficient migration strategies. This ranges from lift-and-shift migration where we leverage Infotechtion solutions built on M365 and Azure machine learning to identify and classify information pre / post-migration, to move-and-improve with meta-data mapping, access group clean-up, etc.

At the core of Information Governance is the need for change and knolwedge management -- the need to deeply embed governance practices, disciplines, and behaviours in the organization. To achieve this, training design and delivery needs to address Hermann Ebbinghous' "Forgetting Curve" to ensure that new knowledge is retained and applied. If not, attendees may only remember 30% of the training after 30 days. Infotechtion will support to develop and deliver effective communication, training with eLearning resources and assist with knolwedge transfer and end user adoption strategies.

Success is 80% about people, 15% about processes, and 5% about the technology. An effective Information Governance program can't

therefore be an IT or Compliance-driven program, - it must be a joint effort with the business. Business leaders and knowledge workers must understand how Information Governance provides value to them and their employer.
