It's an easy-to-use universal remote customer identification, offering maximum versatility, relying on **AI** for seamless biometric security.

Remote Electronic Signature

TORP's eSIGN solution is provided by one of the few **eIDAS** certified European Trust Service Providers which provides **remote** qualified electronic signature.

Moreover, the **end2end eKYC & eSIGN** flow was certified in 2020 as equivalent with the physical presence.

Customer & Application Data Collection

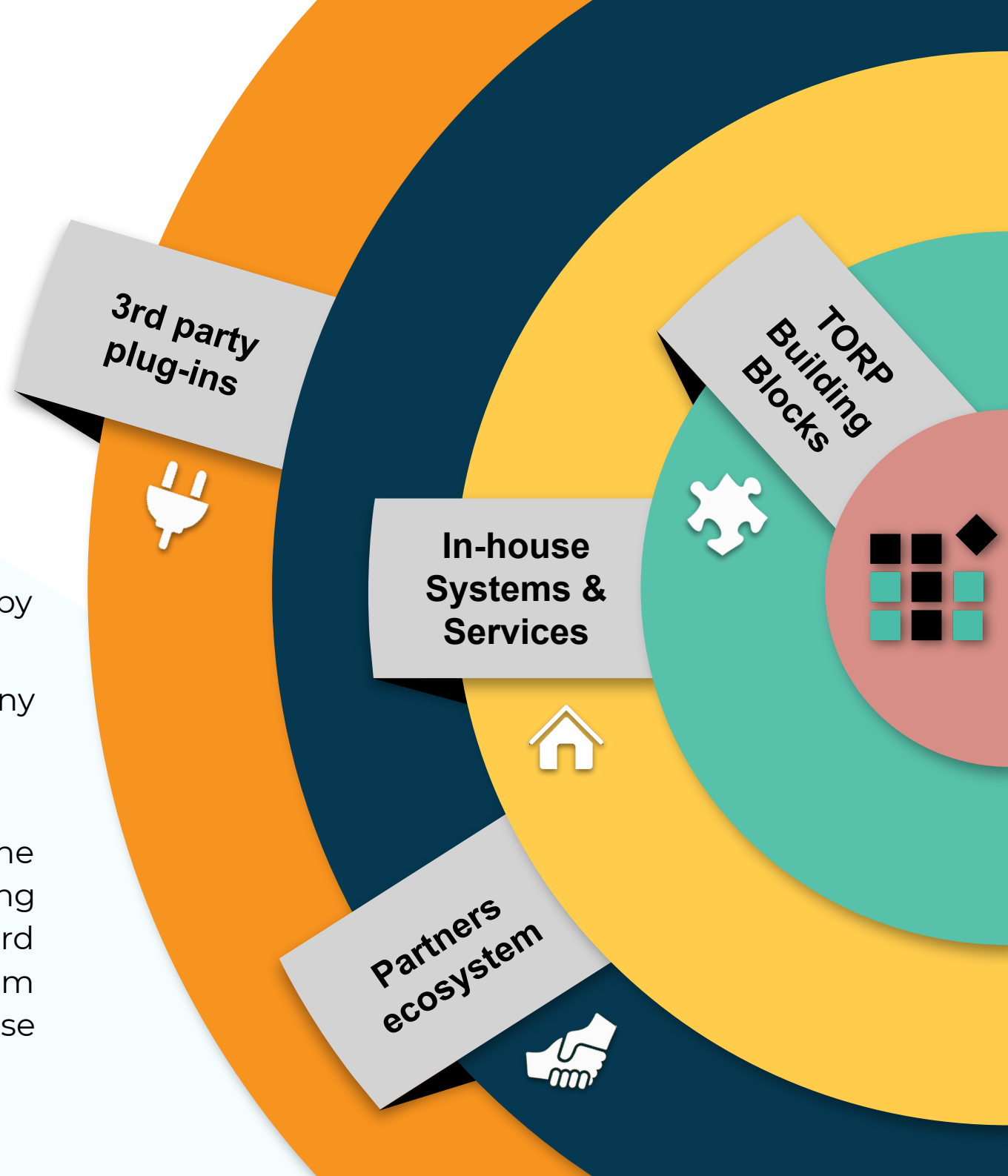
- During the workflow design the business analyst is able to remove or edit existing forms, add new ones in a specific workflow design, edit / remove existing fields or add new ones in the existing forms, being able to set all field properties
- Business logic can also be built throughout the workflow definition using the declared form fields
- Data collected from the customer can be transferred to external services (CRM / Core Banking / Lending Systems)
