

END USER LICENSE AGREEMENT FOR SNAPTURE

IMPORTANT

THIS IS A LEGAL AGREEMENT BETWEEN YOU (“**YOU**” AND “**YOUR**”) AND CII TECHNOLOGY SOLUTIONS, INC. (“**CII**”). CII IS WILLING TO LICENSE THE CII SNAPTURE™ SOFTWARE (THE “**SOFTWARE**”) ONLY UPON THE CONDITION THAT YOU ACCEPT ALL OF THE TERMS CONTAINED IN THIS END USER LICENSE AGREEMENT (“**AGREEMENT**”). PLEASE READ THE TERMS CAREFULLY. YOU MUST CLICK “I AGREE” IN ORDER TO DOWNLOAD AND INSTALL THE SOFTWARE. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, YOU WILL NOT BE ALLOWED TO DOWNLOAD AND INSTALL THE SOFTWARE.

IF YOU ARE ACTING AS AN AGENT FOR A COMPANY, UNIVERSITY, SCHOOL OR OTHER ENTITY, YOU REPRESENT THAT YOU HAVE THE LEGAL AUTHORITY TO BIND SUCH COMPANY OR ENTITY AND SUCH COMPANY OR ENTITY WILL BE SUBJECT TO THE TERMS AND CONDITIONS OF THIS AGREEMENT.

1. Account Registration. In order to license and download the Software, you must register for an account (“**Account**”) by providing your email address, a password for your account, your first and last name, and any other information Cii may require from time to time. You are responsible for maintaining the confidentiality of your Account details and you are fully responsible for all activities that occur under your Account. Your Account must be used only by you and must not be shared with, or transferred to any other individual. You must immediately notify Cii at contact-us@snaptureapp.com of any suspected or actual unauthorized or fraudulent use of your Account or any other breach of security.

2. Privacy Policy. Cii takes your privacy very seriously. Any personal information you submit to us when setting up an Account shall be subject to our Privacy Policy located at <https://snaptureapp.com/privacy-policy/> which is incorporated into this Agreement. You understand that through your opening an Account, you consent to the collection and use (to the extent stated in the Privacy Policy) of this information.

3. Software License.

(a) License Grant.

(i) Cii grants to you a nonexclusive, nontransferable license to install, copy, distribute, and use the executable version of the Software, and any accompanying documentation provided therewith (“**Documentation**”) solely for your internal needs pursuant to the terms and conditions of this Agreement. Each license to install and use the Software is conditioned upon your compliance with the terms of this Agreement. Each Software license allows you to install and use the Software on a single Device. For the purposes of this Agreement, “Device” means a computer hardware system (whether physical or virtual) with a storage device or a mobile device capable of running the Software. A hardware partition or blade is considered to be a Device. Software licenses are floating licenses and are granted for one (1)-year terms. For each license, you may change the Device, but the Software may only be installed and used on one Device at any time. If you would like to install and use the Software concurrently on multiple Devices, then you will need to purchase multiple licenses. For example, if you would like to install and use the Software concurrently on ten (10) PCs, then you would need TO purchase ten (10) licenses. Subject to your compliance with the terms and conditions of this Agreement, an image of the Software may be placed onto an Internal network for the purpose of downloading and installing the Software onto a Device provided that the total number of Devices may not exceed the number of licenses purchased.

(iii) The Software may be activated (“**Activation**”) only with the use of a license key (the “**License Key**”), which is provided with the purchase of your license(s). Activation associates the use of the Software with one or more specific Devices. The License Key tracks and records the number of Devices on which the Software is installed. By way of illustration and example, if you purchase 5 licenses, the License Key will allow you to install and use the Software only on five Devices. During Activation, the Software will send information about the Software and the Device to Cii. None of this information contains personally identifiable information nor can it be used to identify any personal information about you. Cii will provide the License Key via the Internet and you will need to Activate the Software licenses through the Internet. If you renew your license(s), the License Key will be updated to extend your Software license(s) for one or more Renewal Terms (as defined below).

(iii) Cii permits the creation of a reasonable number of backup copies of the Software provided such backup copies are not installed or used for other than archival purposes.

(b) Trial License. A single Software license is provided free of charge for a seven (7) day trial period. The trial version will automatically cease operation after a period of seven (7) days from the date you downloaded the

Software and this Agreement will terminate after such period unless extended by Cii upon your acquisition of a full retail license. Trial licenses are granted pursuant to the terms and conditions of this Agreement, excluding any obligations to pay the applicable annual License Fee for use of the Software during the seven (7) day trial period.

4. Restrictions. The Software may be used only with Devices running the Microsoft Windows® operating system software. Your license to use the Software is limited to the use of the object code of the Software. You agree that you shall not directly or indirectly, either yourself or by assisting a third party, copy, modify, create a derivative work from, reverse engineer, reverse assemble or otherwise attempt to discover any source code, sell, rent, lease, loan, assign, sublicense, grant a security interest in or otherwise transfer any right in the Software, except as expressly permitted hereunder. You agree that Cii may audit your use of the Software for compliance with these terms at any time, upon reasonable notice. In the event that such audit reveals any use of the Software by you other than in full compliance with the terms of this Agreement, you shall reimburse Cii for all reasonable expenses related to such audit in addition to any other liabilities you may incur as a result of such non-compliance. Any distribution, transfer, or posting of the Software made in violation of the requirements, conditions, or restrictions of this section will be void and may result in termination of this Agreement and your licenses.

Cii collects information for fraud and piracy prevention including the number of downloads or installations of the Software through a “call-home” system which may be sent to a Cii or a third party cloud server for storage or further processing by Cii or its vendors that provide license compliance services. Such information may include the IP address and Device and session ID. The Software includes technology designed to prevent unauthorized use and copying. Failure to follow the validation, installation, or license management process for the Software may result in such technology preventing the use of the Software. In addition, Cii utilizes monitoring and scouring technologies to obtain and transmit data on users of illegal copies of the Software. This data collection is not performed on valid and legal Software installations. If you are using an illegal copy of the Software, you are subject to the collection and transmission of such data as described herein. You are advised to cease using the illegal version and contact Cii to obtain a legally licensed copy.

5. Intellectual Property Ownership. The license of the Software is not a sale. Title, ownership rights, and intellectual property rights in and to the Software and Documentation shall remain in Cii. You agree to abide by the copyright laws and all other applicable laws of the United States. Failure to comply with the above restrictions will result in automatic termination of this license and will make available to Cii other legal remedies. You may not disclose any of Cii’s proprietary or trade secret information relating to the Software to any third party. You agree to secure and protect the Software, Documentation and copies thereof in a manner consistent with the maintenance of Cii’s rights therein and to take appropriate action by instruction or agreement with your employees or consultants who are permitted access to the Software to satisfy your obligations hereunder.

6. License Fees. The annual license fee for the Software (the “**License Fee**”) is the amount then-quoted by Cii when you sign up for or renew your license for a one (1)-year term. Cii reserves the right to update the License Fee from time to time. When you sign up to purchase a license to the Software you will be directed to our third party payment processor (e.g., Stripe, etc.) for payment. All payments are due in advance and are nonrefundable. Approximately seven (7) days before the date that the Initial one (1)-year license term (the “**Initial Term**”) or each Renewal Term (as defined below) will expire, Cii will notify you of the pending expiration of the license and may provide you with the opportunity to extend the license for an additional one (1)-year period (a “**Renewal Term**”), subject to payment of the applicable License Fee. If you do not elect to renew your license and pay this annual License Fee, your license shall automatically terminate upon expiration of the Initial Term. You acknowledge that, if Cii changes the License Fee, this will not affect your existing licenses during the current annual period.

7. Deleting Your Account. You can delete your Account and terminate your Software licenses at any time by locating the Customer Portal and accessing the ‘Delete Account’ option in your Account settings. Once you have deleted your Account, all Software licenses under your Account will be terminated and the Software will be deactivated. You will no longer have access to the Software. If you have an active Software license when you delete your Account, you will not receive a refund for any time remaining with respect to that license.

8. Termination of Your Account by Cii. We reserve the right to modify, temporarily suspend or permanently delete your Account and terminate your Software license(s) if Cii has reason to believe that you have breached or acted inconsistently with the terms of this Agreement. Following termination, all Software licenses under your Account will be automatically revoked and Cii reserves the right to delete your Account and all of your Account information. If you have an active Software license when Cii deletes your Account, you will not receive a refund for any time remaining with respect to that license.

9. No Representations or Warranties. You understand and agree that the Software is provided “as is” and that your use of the Software is at your own risk. To the fullest extent permitted by applicable law, Cii MAKES NO

WARRANTIES, EXPRESS OR IMPLIED, WITH RESPECT TO THE SOFTWARE AND DOCUMENTATION AND SPECIFICALLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT. CII DOES NOT WARRANT THAT THE OPERATION OF THE SOFTWARE WILL BE UNINTERRUPTED OR ERROR FREE. NO RIGHTS OR REMEDIES REFERRED TO IN ARTICLE 2A OF THE UCC WILL BE CONFERRED ON YOU UNLESS EXPRESSLY GRANTED HEREIN. THE SOFTWARE IS NOT DESIGNED, INTENDED OR LICENSED FOR USE IN HAZARDOUS ENVIRONMENTS REQUIRING FAIL-SAFE CONTROLS, INCLUDING WITHOUT LIMITATION, THE DESIGN, CONSTRUCTION, MAINTENANCE OR OPERATION OF NUCLEAR FACILITIES, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL, AND LIFE SUPPORT OR WEAPONS SYSTEMS. CII SPECIFICALLY DISCLAIMS ANY EXPRESS OR IMPLIED WARRANTY OF FITNESS FOR SUCH PURPOSES.

NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY CII, ITS DEALERS, DISTRIBUTORS, AGENTS OR EMPLOYEES SHALL CREATE A WARRANTY.

SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER LEGAL RIGHTS THAT VARY FROM STATE TO STATE.

10. Limitation of Liability.

(a) NEITHER CII NOR ITS SUPPLIERS SHALL BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE, COVER OR CONSEQUENTIAL DAMAGES (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR THE INABILITY TO USE YOUR COMPUTER HARDWARE OR ACCESS DATA, LOSS OF BUSINESS, LOSS OF PROFITS, BUSINESS INTERRUPTION OR THE LIKE), ARISING OUT OF THE USE OF, OR INABILITY TO USE, THE SOFTWARE AND BASED ON ANY THEORY OF LIABILITY INCLUDING BREACH OF CONTRACT, BREACH OF WARRANTY, TORT (INCLUDING NEGLIGENCE), SOFTWARE LIABILITY OR OTHERWISE, EVEN IF CII OR ITS REPRESENTATIVES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF A REMEDY SET FORTH HEREIN IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.

(b) CII'S TOTAL AGGREGATE LIABILITY TO YOU FOR ACTUAL DAMAGES FOR ANY CAUSE WHATSOEVER AND FOR ALL CLAIMS AND DAMAGES WILL BE LIMITED TO THE MOST RECENT ANNUAL LICENSE FEE PAID BY YOU FOR THE SOFTWARE THAT CAUSED THE DAMAGES. THIS LIMIT IS AN AGGREGATE LIMIT THAT WILL NOT INCREASE ACCORDING TO THE NUMBER OF CLAIMS BROUGHT BY YOU.

11. Indemnity. You agree to indemnify, defend, and hold Cii, its officers, employees, contractors, suppliers, affiliates, agents and licensors harmless from and against any losses, damages, cost, expense (including reasonable legal fees) or other liability, arising out of any claim, demand, allegation or proceeding brought by any third party due to, or arising out of your use of the Software or your breach of this Agreement.

12. Support Services. Cii does not offer or make available any real-time support services for the Software. If you have any problems or difficulties, please visit our Users Guide at: <https://snaptureapp.com/user-guide/>.

13. Governing Law. This Agreement is to be construed and governed in accordance with the internal laws of the State of North Carolina without reference to conflict of law principles. Any controversy or claim arising out of or relating to this Agreement, or the negotiation or breach thereof, shall be settled by arbitration in accordance with N.C. Gen. Stat. § 1-569.1 *et seq.* (the "Revised Uniform Arbitration Act") and the then-current Rules of Commercial Arbitration of the American Arbitration Association, and judgment upon the award rendered by the arbitrator may be entered in any court having jurisdiction thereof. The arbitration shall be held in Raleigh, North Carolina and shall be conducted in the English language, and shall be conducted before a single arbitrator mutually agreeable to the parties, or if no agreement can be reached, then selected by the American Arbitration Association. The arbitrator shall award reimbursement of attorneys' fees and other costs of arbitration to the prevailing party, in such manner as the arbitrator shall deem appropriate. In addition, the losing party shall reimburse the prevailing party for the costs and expenses incurred by it, including attorneys', arbitrators' and courts' fees and expenses, in connection with any action or proceeding hereunder. If any court having proper jurisdiction hereof shall subsequently determine any portion of this Agreement to be invalid, such designation shall not affect the remaining provisions of this Agreement, which will continue in full force and effect. If, under applicable law, this arbitration provision is not enforceable as to a particular claim brought by one party against the other, then legal proceedings involving only that claim may be instituted solely either in the state court for the State of North Carolina, County of Wake, or in the United States District Court for the Eastern District of North Carolina located in Raleigh, North Carolina. For all purposes of this Agreement, all parties hereby irrevocably consent to the jurisdiction of such courts over their person and waive any defense based on improper or inconvenient venue or lack of personal jurisdiction.

14. U.S. Government Restricted Rights. The Software and documentation are provided with RESTRICTED RIGHTS. Use, duplication, or disclosure by the government is subject to restrictions as set forth in subparagraph (c) (1) (ii) of the Rights in Technical Data and Computer Software clause at DFARS 252.227-7013 or Rights at 48 CFR 52.227-19, as applicable. The Manufacturer is Cii Technology Solutions, Inc., 4700 Six Forks Road, Ste. 300, Raleigh, NC 27609. As a condition to the license granted under this Agreement, you agree that the Software may not be downloaded or otherwise exported or re-exported: (i) into (or to the national resident of) any country to which the U.S. has embargoed goods; or (ii) to anyone on the U.S. Treasury Department's list of specially Designated Nationals or the U.S. Commerce Department's Table of Denial Orders. By using the Software, you agree to the foregoing and represents and warrants that neither you are not located in or under the control of, a national resident of any such country or on any such list.

15. Miscellaneous. This Agreement sets forth the entire agreement between you and Cii pertaining to the licensing of the Software, and supersedes in its entirety any and all written or oral agreements previously existing between the parties with respect to such subject matter. Failure to enforce any provision of this Agreement will not constitute a waiver. Any waiver must be in writing and signed by the waiving party. If any provision of this Agreement is held invalid or unenforceable, such provision shall be revised to the extent necessary to cure the invalidity or unenforceability, and the remainder of this Agreement shall continue in full force and effect. In the event of any conflict between any provision of this Agreement and any applicable law, the provision or provisions of this Agreement affected shall be modified to remove such conflict and permit compliance with such law and as so modified this Agreement shall continue in full force and effect. This Agreement may not be assigned without the written consent of Cii.
