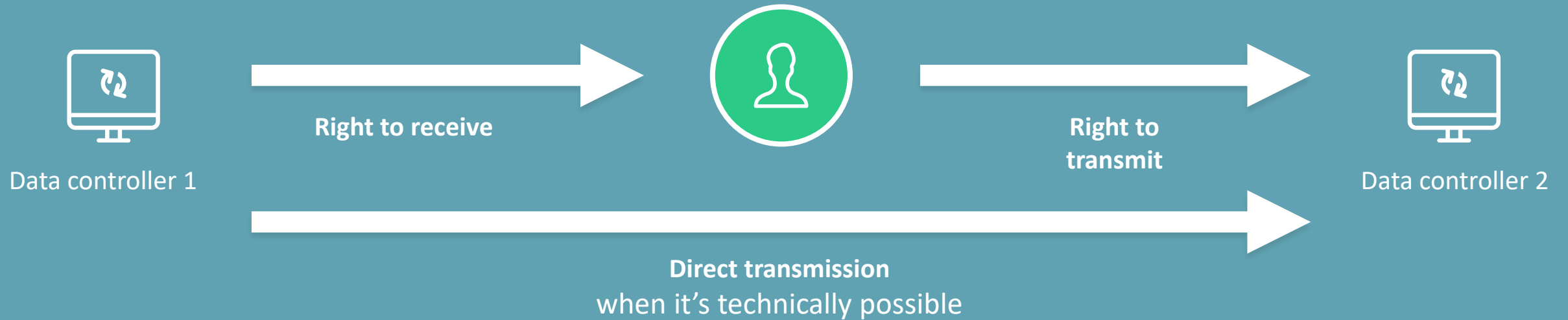

What does the GDPR Portability Right ask you?



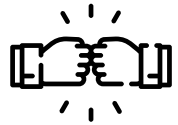
« [He or she] has the right to transmit this data to another controller without hindrance from the controller to which the personal data has been provided »

DATA CONCERNED BY PORTABILITY RIGHT

Actively submitted data with consent name, address, date of birth, etc.

Passively submitted data by using service browsing history, location, shopping history, etc.

TWO TYPES OF PORTABILITY



Competition Portability data is transferred from one service to a competing service

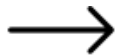
Makes markets more fluid



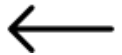
Cooperation Portability data is transferred from one service to a complementary service

Portability final purpose is to allow persons to transfer data

- Privacy by design VS seamless UX

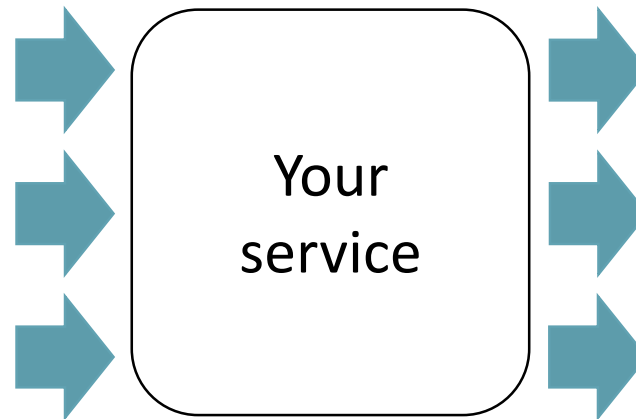

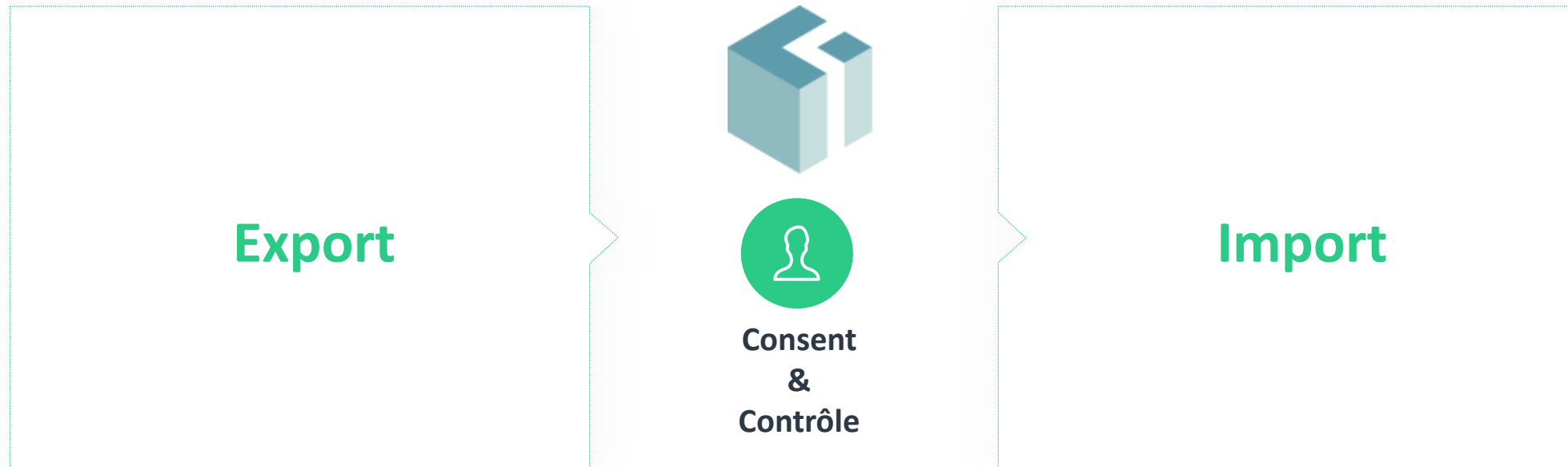
What does Onecub offer?

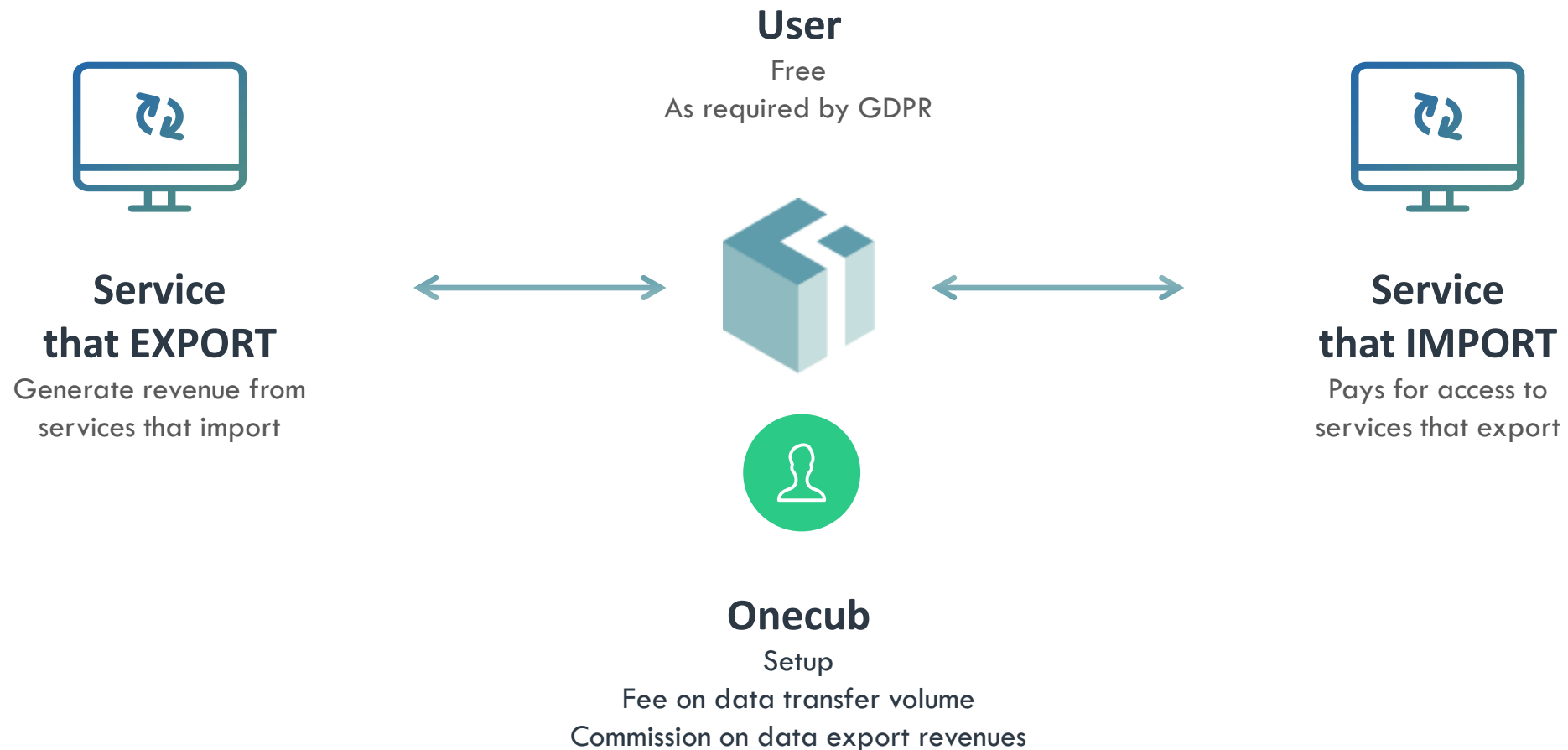
