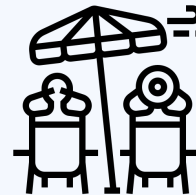

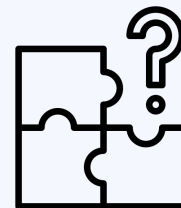

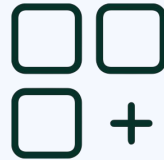

Software should break down silos, not create new ones.

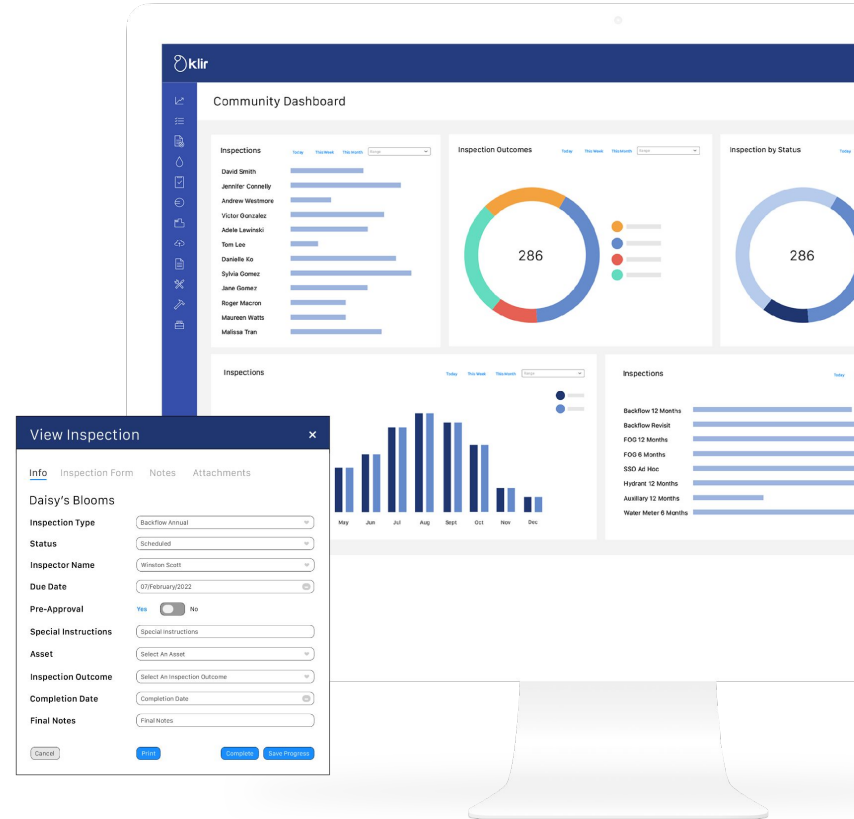
