We enable verification of an assertion of parental responsibility to happen remotely and to a higher level of reliability than an in-branch verification check against authoritative data TrustElevate is the first company globally to provide such a solution.

How it works

- TrustElevate's API verifies an assertion of parental responsibility for <18, , verifies a child's Identity and Age, so a verified parent can enter into a contract with bank on behalf of child (Verified Parental a Authorisation).
- TE operates a large scale 'point in time matching service'; TE makes multiple calls against the data sources (government and non-government data sources).
- Data is encrypted in transit, and we provide receipts.
- There is no need to collect or store additional information, such as scanned passports or facial recognition.


