



AZURE SERVICE	USED FOR
Azure Frontdoor	Used as WAF to block malicious requests and attacks
Azure VM	Used for deploying the UI and Middleware application
Azure Active directory	Used for Authentication, Authorization and user management
Azure Defender	Used for scanning all the documents being ingested
Azure Data Factory	Used for building and managing data ingestion pipelines
Azure Blob	Used as centralized data store
Azure Cognitive Search	Used for saving embeddings and retrieving chunks while querying
CosmosDB	Used for saving the metadata of uploaded files and queries
Azure ML Studio	A collaborative platform used to build and deploy ML solutions
Azure Al Vision	Used to analyze content from images and videos
Azure Al Document Intelligence	Used for extracting data from documents
Azure Al Speech	Used for speech to text capabilities
Azure Functions	Used for triggering indexes for new files in Blob storage
