AML Regulatory Risk (US & EU)



US

- BSA-related AML <u>criminal penalties</u> include a fine of no more than \$250,000, imprisonment for no more than five years, or both. However, if the violation is part of a pattern of any illegal activity involving more than \$100,000 in a twelve-month period and involves the violation of another US criminal law, the fine can be up to \$500,000, imprisonment for up to ten years, or both.
- ➤ The maximum BSA-related <u>civil penalties</u> can vary significantly. For example, federal banking regulators have the authority to impose anti-money laundering penalties from \$5000 per violation to \$1,000,000, or 1% of the assets of a financial institution, whichever is greater, for every day that the violation occurs.

EU

- Obliged Institutions may be fined 5 mln EUR or 10 % of yearly turnover from the previous year balance sheet
- Senior Management personal liability (both financial and criminal) (from 3 months to 5 years in prison)




