

Stale or Untrustworthy Employee Credentials

- Uncertainty that workers have the current and certifications to perform the roles at any time
- Labour intensive process to background check and maintain career credentials

Data Security & Inter-department Accessibility

- Separate systems by region or department host employee credentials creating inaccuracies.
- Risk of identity breaches with storage and sharing procedures that risk violating privacy regulations


