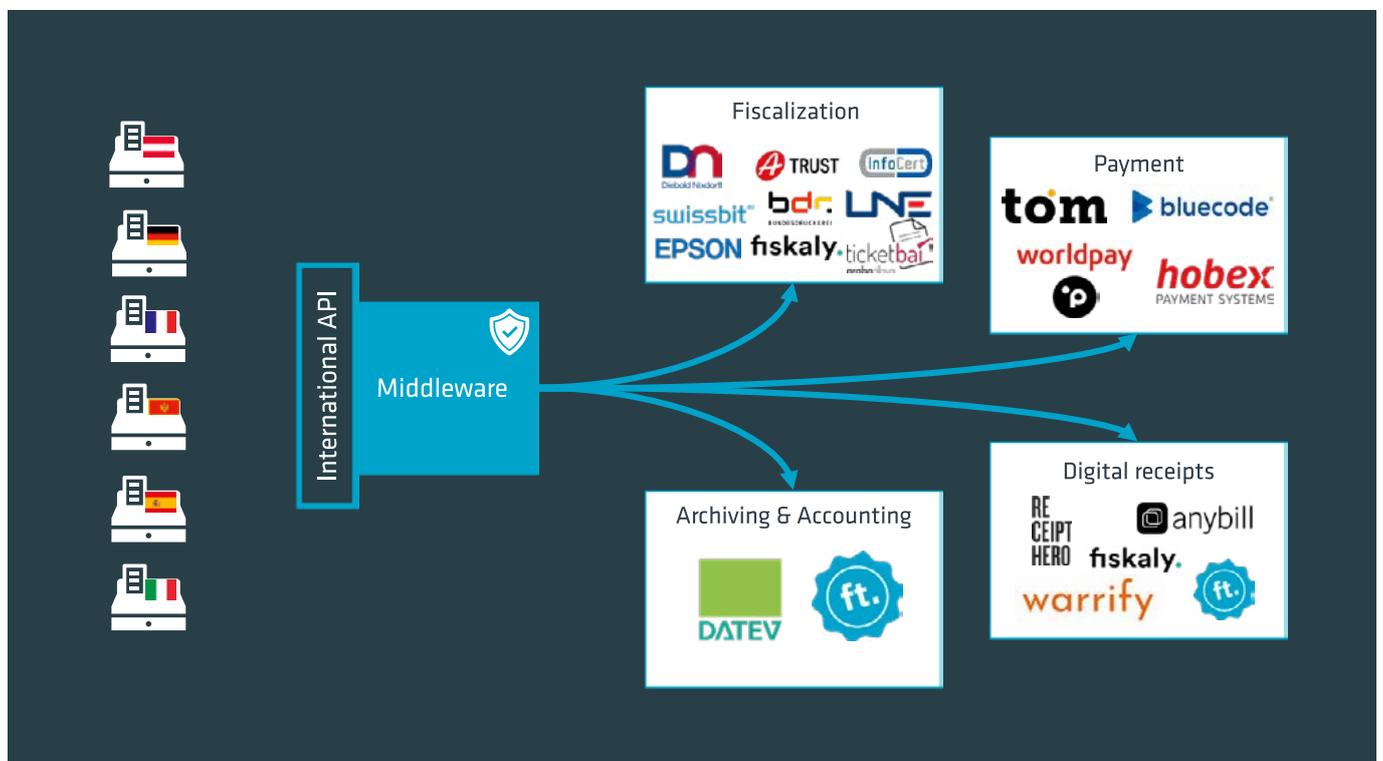


# Middleware Solution

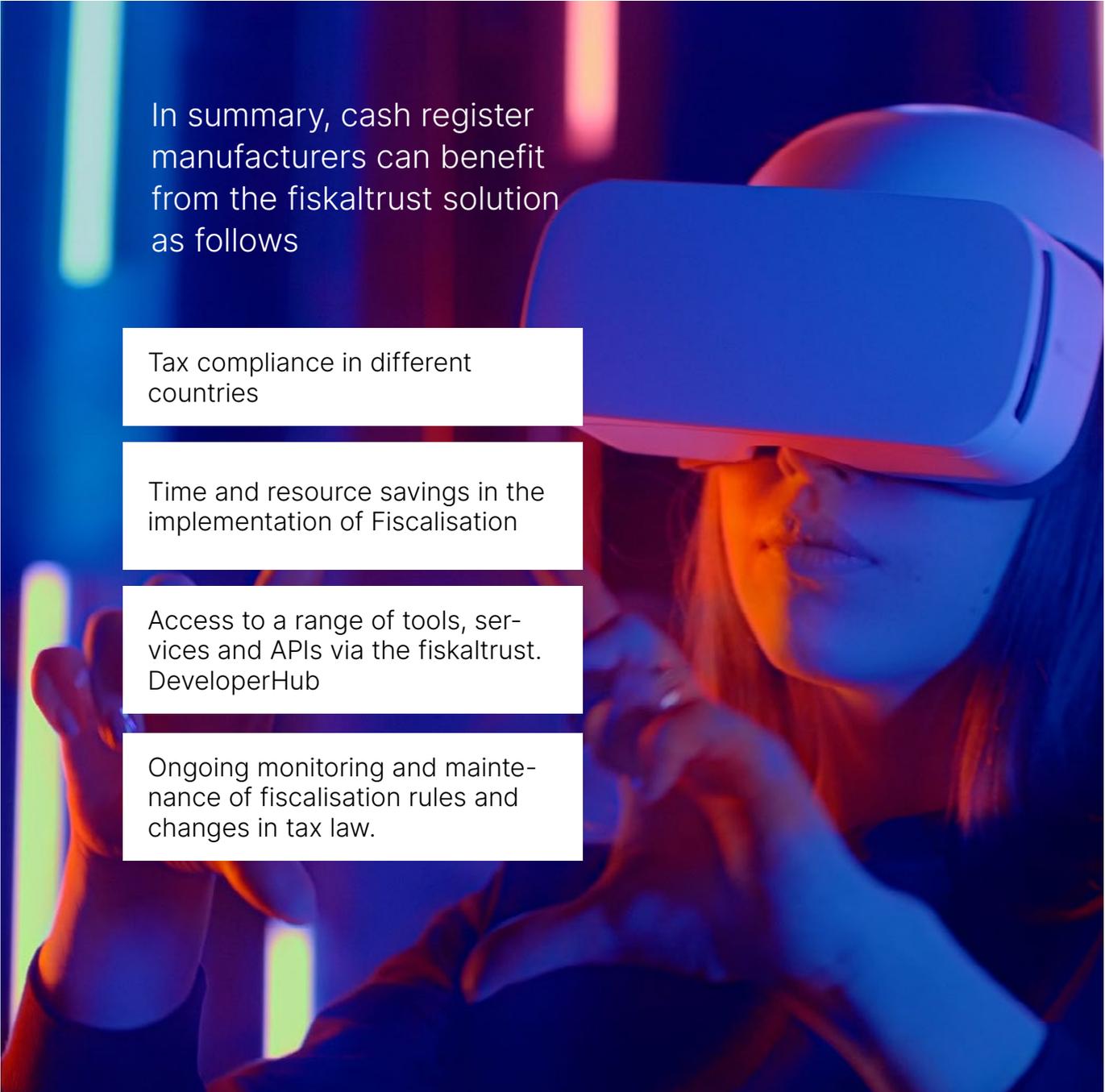
