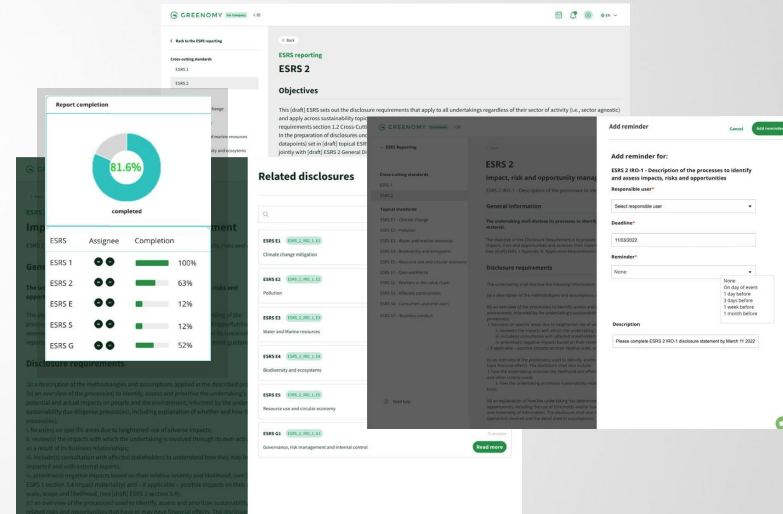
The CSRD mandates large companies to report in compliance with European Sustainability Reporting Standards (ESRS). There are **12 ESRS: 2 cross-cutting** and **10 topical standards** that include **~1,200 data points**. Companies will have to apply the new rules for the first time in 2025 based on their 2024 data.

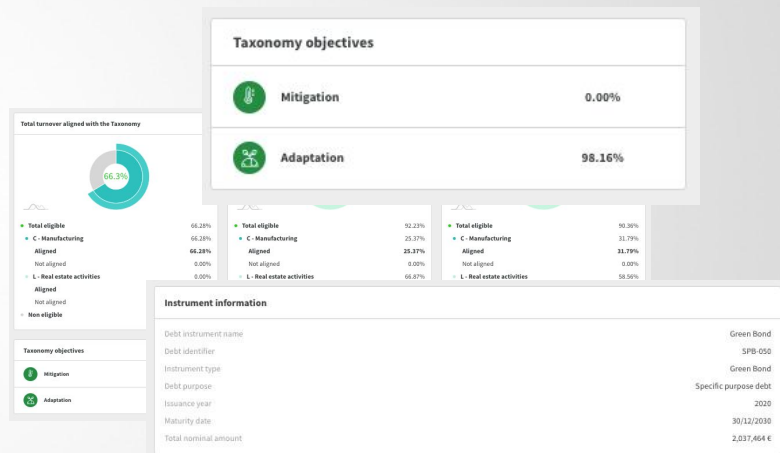

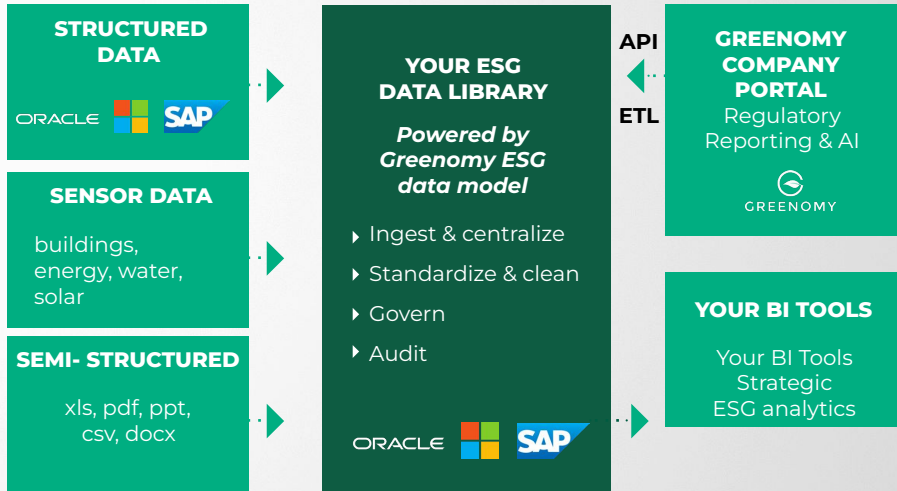
