





## *Risk-Based* Triage : Determining of the appropriate level of assessment

#### THIRD PARTIES CATEGORIZATION

Establishing criteria and angles for screening - *Risk-Based* Triage; in order to categorize Third Parties:

Proposed decision matrix ==> *Risk-Based* Triage process:

- multi-criteria: Country Risk Index, type of activity, category of Third Parties, volume of business, etc...
- compounded: according to the business models/ecosystems specific to each industry/organization
