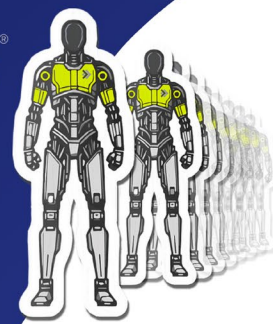


Our Risk Principles & Innovations

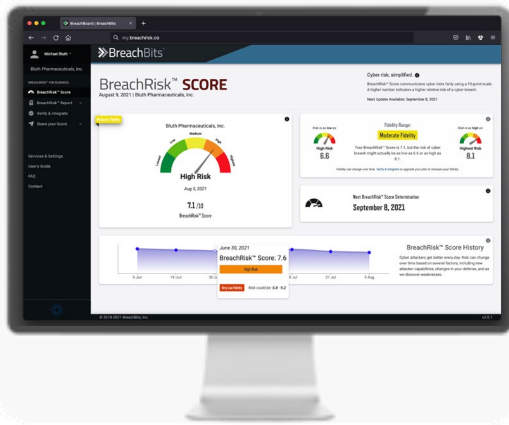

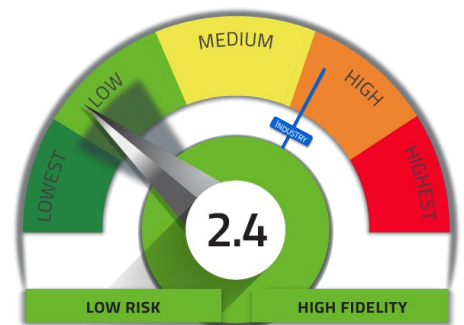
