Data Transmission: IntegraLynx enables the collection and dissemination of information/files via multiple transfer mechanisms e.g email, SFTP, API, direct database connectivity.



Data Import/Export: Processes can be easily created to import/export data from/to a variety of file formats including excel, .csv, .txt, .xml, and .pdf. Data completeness and quality checks are applied as data is imported.



Data Model & Storage: Integralynx supports the efficient implementation of data models tailored to client's precise business requirements. Objects, their characteristics/fields, and linkage to each other are all easily defined, reviewed, and managed through a user-friendly interface. The core underlying philosophy is to "gather data once and use it many times".



Data Processing & Calculations: Leveraging data collected and validated IntegraLynx enables users to create complex calculation routines to produce and store new data.



Oversight & Analysis: IntegraLynx provides multiple approaches to reviewing, analysing, and visualising data consumed and produced - including in-built drilldown reports, .pdf templates, SSRS reports, and PowerBi dashboards.

Governance: All access and activity within IntegraLynx is controlled through a fine grained and configurable roles-based user permission framework.
