We created a product that adapts to organizations' needs independently of the business area.

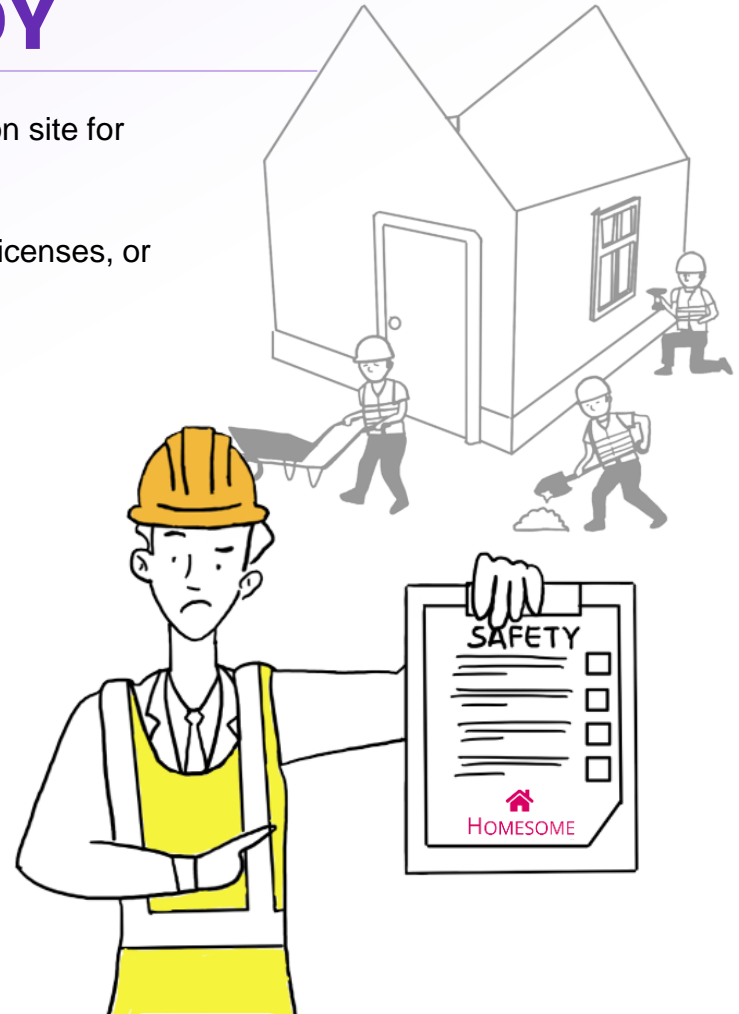


CASE STUDY

Let's imagine that your company (let's call it **HomeSome**) runs a construction site for building a house!

When the construction site manager asks you about workers, construction licenses, or machine inspections, how do you proceed?

- Where are the legal documents mandatory for building the house?
- Is my documentation updated or has some document expired?
- Is my documentation safe or someone could have tampered with it?
- Does the company that was signed to build the roof has all this documentation updated and available?



CASE STUDY

The company that is building the roof (let's call it **YourRoof**) needs to track the same documentation that your company does.

The workers and machines that are entering and leaving the construction site need to be tracked.

- We have multiple projects and workers/machines can move between them. How can I handle it?
- How can I maintain updated data in all my projects and guarantee document validity?
- If we need to contract with a company to paint the roof, how can I handle such number of documents across all organizations?



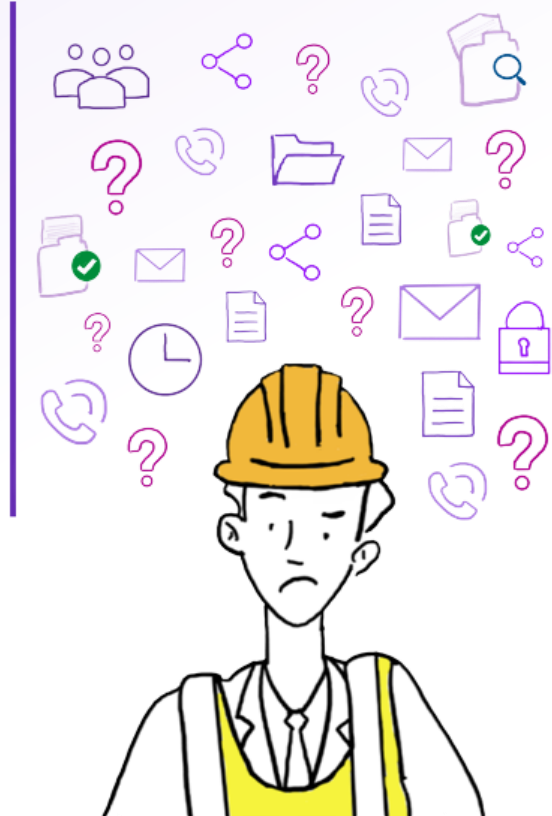
PROBLEM

Non-compliance with legal requirements

According to the IMF report, deficient data and information costs the US construction industry over US\$ 31.3 billion in 2018.

Communication delays

According to a [Project Management Institute](#) study, for every US\$ 1 billion spent on a project, approximately US\$ 75 million is due to a lack of communication between the professionals involved.



Slow response to change requests

Construction projects generate an average of 56 change requests per project. A delay of a few hours can result in wasted materials and labor.

Work overload to those who approve documents

Documents approval is time-consuming, jeopardizing the tasks inherent to effective project management.

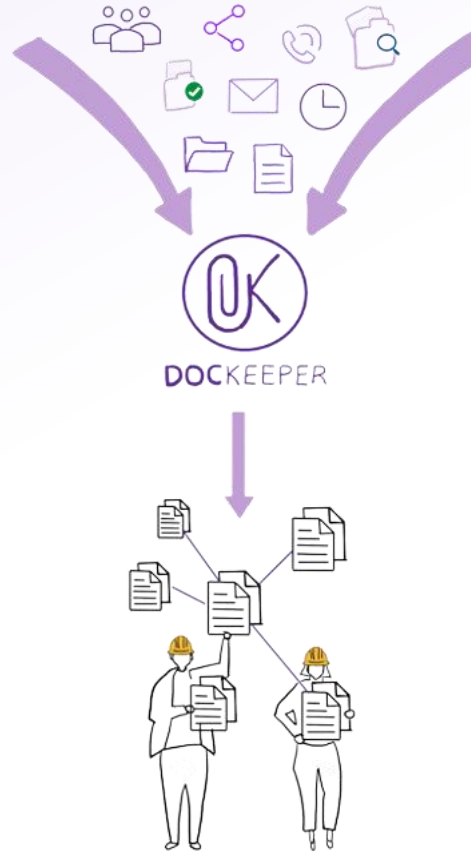
SOLUTION

Version control and history automation

DocKeeper allows each document to have a set of versions, always keeping their history automatically.

Access Configuration

DocKeeper allows configuring user groups with different permissions, ensuring a high-level security in accessing documents.



Document linking and Update flow automation

DocKeeper allows linking documents to projects, making their update reflected by all projects where they are linked - automatically.

Approval flow

DocKeeper allows a project owner to approve subproject documentation. Failures in document validation can lead to fines payments, harming the smooth running of the organization.

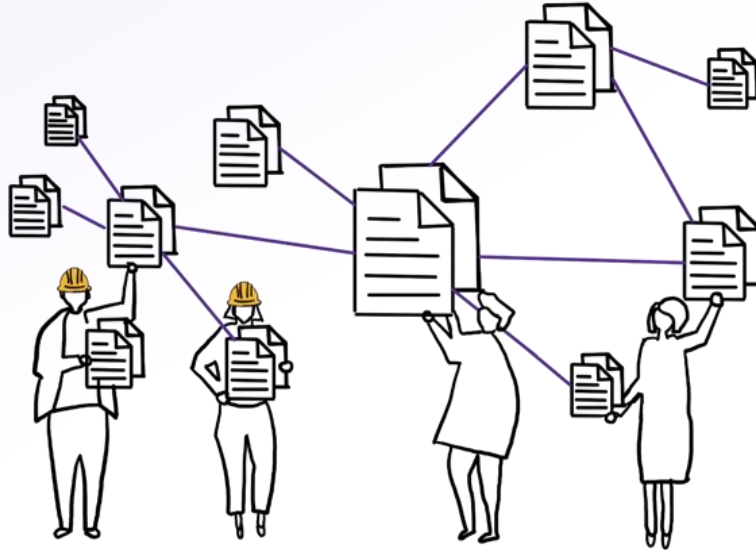

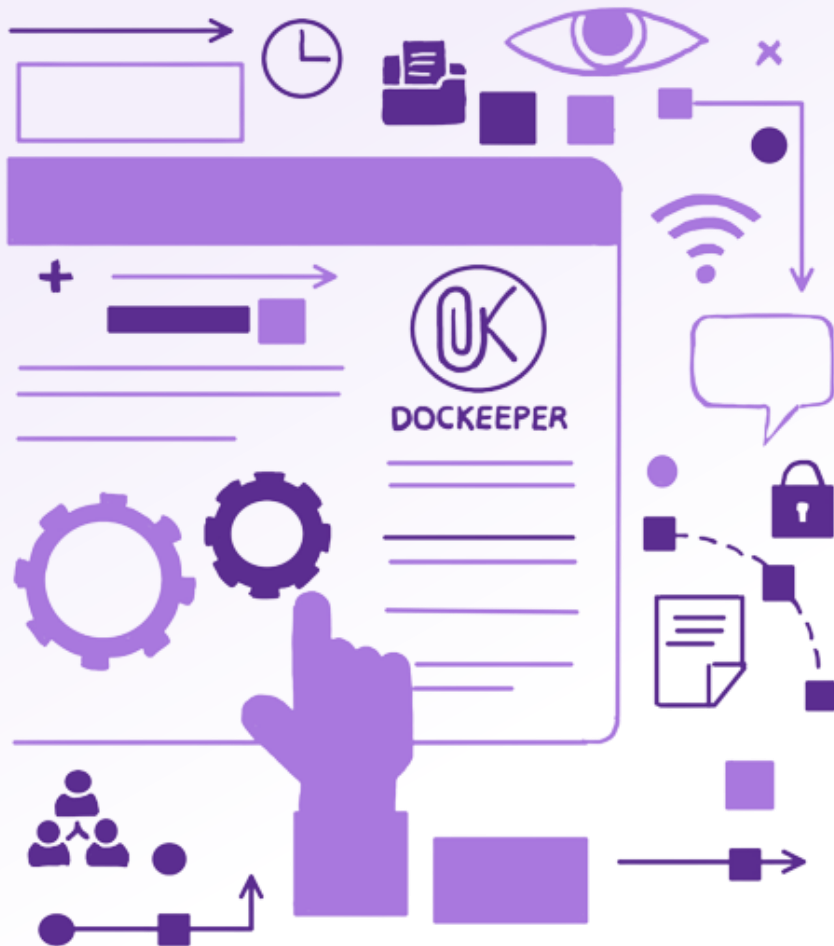
