# Retails continue to leak money across Source to pay value chain year over year

Complex business processes, dynamic commercial terms and multiple frequent suppliers' transactions are exposing Retail and eCommerce organizations to the risk of overpayments. Contract compliance becomes even more difficult in a retail dynamic environment where there are numerous supplier agreements and email exchanges due to high volume of events, intermittent deals and promotions, retail price adjustments, seasonal variations, and joint campaigns.

In many cases, agreements with suppliers made through email exchanges are not documented in a centralized deal or coop management system leaving the retailer exposed to overpayment or missed fundings with suppliers. Analysing unstructured data including email communications between buyers and suppliers for references to terms, conditions, or commitments made between the parties, have been labour-intensive, time-consuming, and prone to human errors.

These errors are costing companies millions of dollars. The percentage of leakages for retailers could range from 0.2% to 0.5% of supplier spend. This implies that a retailer operating with even very effective controls with an annual spend of \$10B has leakages of ~\$20M annually.








# Leveraging generative AI powered audit to have a closer look at unstructured data

When a query is fired, relevant chunks are extracted, and answer is created using RAG (Retrieval Augmented Generation) based approach. The tool offers cutting-edge capabilities that revolutionizes the way we search for contract commercial terms and relevant emails to conduct audits, ultimately improving efficiency, accuracy, and recovery opportunities.
