

# 1 STANDARD PACK FEATURES

## 1.1 VAT forms (VAT Statement, PDV-S, PDV-ZP, OPZ-stat)

Taxpayers have obligation to regularly submit VAT forms. Forms should be submitted monthly or quarterly, depending on the size of your business and total income.


The VAT forms can be created automatically from NAV. In Search bar you should type in "VAT DS". List of VAT reports that matches this description will appear.



### 1.1.1 VAT Statement (Form)

The taxpayer should, for the taxation period, determine the VAT liability and state it in the VAT statement, which lists all the information required for the calculation.

Select "VAT Form DS" from the list and click on it. New window will automatically open.



Here you need to enter taxation reference period. Optionally you can enter other relevant data such as Pre-tax corrections, Return or Deposit from previous period, etc.

Once you entered reference period click Preview.




Please note the only parameters that can be changed are information as to who represents your company for taxation purposes and how to contact them as well as default filters for some VAT forms. The structure of the forms themselves is not configurable and complies with the e-Tax system requirements in order for the forms to be successfully loaded and submitted.

Any changes in setup regarding structure must be performed by Dignet and only when legal requirements or reporting formats change, as detailed knowledge of Croatian tax rules and formats is required.

### 1.3 VAT books (Issued invoice / Received invoices)

In addition to VAT statements, Received and Issued invoice books are obligatory for submission to tax authorities. They enable inspection and control of VAT amounts shown in the VAT statement. These Books have options for preview and printing and export to XML data format for import into e-Tax for a given tax period.

The simplest way to find the invoices books is by typing "book ds" in the Search bar.

## 1.8 Printout of sales documents according to Croatian regulations

The documents considered here as sales documents are invoice, credit memo, delivery note, prepayment invoice, prepayment credit memo and final invoice.

All elements that are required by law are clearly visible on the printout.

Documents can be printed in Croatian and English, depending on the language code setting on the customer card. Documents can be saved as pdf file for sending it via e-mail.

You can choose to print sales document right after posting it with function Post and Print or you can print document later. If you go to posted document, click to Actions ➤ Print.




## 2 ADVANCE PACK FEATURES

### 2.1 Integration with banks through SEPA format files

If your bank gives you the option to save a bank statement for import into the program, it can be imported into the payment journal. If Bank reconciliation journal is used, then after bank statement is imported it can reconcile entries on bank statement with already posted Bank account ledger entries – for example payments made and posted on Payment journal.




All entries that cannot be reconciled with Bank account ledger entries can be transferred to General journal and then posted.



If Payment reconciliation journal is used then after bank statement is imported it can reconcile entries on bank statement with already posted Bank account ledger entries, with customer/vendor open entries or can suggest accounts for posting according to Map Text


to account setup. All not reconciled amounts can be settled up to be posted to specific account using Transfer Difference to Account function.



This functionally imply preparation of files in SEPA format for uploading to net-banking to make payments. It is standard functionality but it had to be modified to compile to Croatian banks files.

Payment journal can be used to prepare files in SCTHR format (standard SEPA format modified for Republic of Croatia) for uploading to net-banking to make payments.

Payments can be prepared by using Suggest Vendor payments. This can suggest payments according criteria that are used (date, posting groups, specific vendors...). Or it can be manually entered into payment journal (if you want to pay something according to offer or without invoice). After payments are prepared it can be exported and created xml file that can be imported in bank system for payment.



## **2.2 eInvoice**

The Dignet localization supports sending of Sales Invoices and Credit Memos as well as receipt of Purchase Invoices and Credit Memos thru third party eInvoice providers. E-invoices are in essence invoices and credit memos sent in a specific format (defined by the European Union and/or the local government) in such a way that full accountability exists. It can always be confirmed when a document was sent, if it has been received and when. The integrity and source of the document are also verifiable.

This exchange of documents is enabled by third-party service providers. The standard provider supported by the standard Dignet e-Invoice module is Moj-Eračun. Proper registration with this service provider and connection setup in NAV is required before e-Invoice functionalities can be used from within NAV. Registration and provision of connection data is the client's responsibility.

### **2.2.1 Sending Sales eInvoices (applies also to Credit Memos)**

On the Posted Sales Invoices additional actions have been provided for sending invoices to clients. For immediate sending of Invoice, select the "Send eInvoice" option.

Upon executing this action (may take up to 30 seconds depending on Internet connection speed and service saturation at the time of day), NAV will immediately update the Posted Sales Invoice with additional eInvoice information indicating the status of sending and the unique ID number every document receives when sent.

If the invoice has been successfully sent, the indicated status will be "Sent".

If the information shown under "eRacun Id" is empty, most likely there is no connection to the third-party services provider or internet in general.

Otherwise, if an "eRacun ID" has been returned, the problem is with the document data itself. The most common source of problems are invalid VAT ID or e-Mail addresses entered in the customers data.

### **2.2.2 Sales List information**

In addition to eInvoicing information shown on the Posted Sales Invoice itself, the information is also available on the Posted Sales Invoices List:

This enables you to quickly filter all documents based on their e-Invoice status and determine which documents have not been sent yet.

### **2.2.3 Sending Attachments**

E-invoices are capable of having multiple attachments. The most common type of attachment is a PDF version of the Posted Sales Invoice itself. This attachment is created automatically when sending documents (created by printing the Sales Invoice to PDF).

It is also possible to send multiple additional attachments. These attachments are supplemental documents and must be available as PDF files. A typical second attachment would be an invoice specification or notifications of changes in sales or service terms. Please note that such additional attachments are external files and are not automatically created or added by NAV.

Additional attachments can be added to the Posted Sales Invoice before sending eInvoice.

### **2.2.4 Receiving Purchase eInvoices (applies also to Credit Memos)**

Importing received e-invoices is also additional feature within localization.

For importing eInvoice in NAV, using search bar you should open eInvoice Import functionality. Then click Receive Documents button.

Functionality will automatically import all new invoices received thru eInvoice platform.

While importing, functionality will mark imported invoice, so that next you start Importing, these invoices will be skip. This way possibility to post same invoice twice will be avoided.

As soon as these lines are imported to eInvoice Import table, transferring data to Purchase order or Purchase invoice will start, too.

Once data were imported to orders or invoices, field "IsImpored" will have mark. If there were some error and order/invoice is not created, these field will stay blanc.

### **2.2.5 Purchase List information**

If order/invoice is created out of eInvoice import, field "Electronic Id", which is located in document header, will have value. That same value you can find in eInvoice Import table shown in section above. This way received and imported eInvoices are easily identifiable.

Information is also available on the Purchase Order list or Purchase Invoices List.

### **2.2.6 Setups**


Only setup that client needs to enter is valid VAT Id on both Customer's and Vendor's card. And valid e-mail address on Customer's card to which eInvoice notification will be send.

All other setups are technical nature and Dignet will filled them in as needed.

## 2.3 Modified prepayment invoices and credit memos

This functionality is standard in BC but it had to be modified to compile to Localization posting setup and VAT reports.

This functionality applies to both sales and purchase unposted orders and extends these documents with additional postings for prepayments. Prepayment posting is available from orders as shown below:



Once you entered all necessary data in a sales or purchase order, click on the dropdown list with prepayment document postings. By selecting "Post prepayment invoice".

This will post prepayment invoice which will be listed in Customer's/Vendor's Ledger entries. You can find them among Posted sale or posted purchase invoices. If you defined Posting No. series for Prepayment, this invoices will have different posting number than standard invoices. It posts VAT base amount and VAT amount to G/L accounts as defined in the setup.

Once Prepayment invoice is posted, that Order have status Pending Prepayment.

After the goods have been delivered or services rendered for which a prepayment has been received and posted as described before, the prepayment credit memo and the final invoice from that same order can be posted.

If there were a mistake in prepayment posting, you can cancel with posting Prepayment credit memo. This posting will reverse the previously created prepayment postings.

If prepayment invoice posting is regular, you can just post final invoice from this Order in usual way. Posting of final invoice will automatically cancel prepayment posting in G/L and post another entries for goods or service. This way, final invoice will have amount 0,00.

Final posted invoice which contains all legally required elements for this type of transaction.

## 2.4 Exchange rate download

This automatic entry of the HNB middle exchange rate for the currencies used in daily work, is meant to reduce the possibility of human error in entering it. This service can be preset at Currency Exchgt. Rate Service.

The exchange rate entry procedure is automatically performed at preset day time.

If a different exchange rate is required on certain documents, it can be changed manually on each individual document or journal entry without disturbing the HNB mid-course already entered.

## 2.5 Posting Compensation Proposal

This functionality adds the capability to propose compensations for parties that are both Vendors and Customers to your business. In Croatian terms a compensation is a legal agreement and document by which two parties agree to pay only the difference in due balance and are allowed to use this agreement to close open sales and purchase invoices.

This procedure depends on the Vendor and Customer having the same VAT ID entered in their respective Cards.

The procedure is started from Payment Journals by selecting the action show below:
