What is electronic invoice?

According to Article 3 of Circular 32/2011/TT-BTC, explains the concept of e-invoices as follows:

“Electronic invoice is defined as a collection of electronic data messages about selling goods and providing services. For the creation, preparation, sending, receiving, storage and management of e-invoices will be via electronic means and comply with regulations of the Ministry of Finance”

Electronic invoices include:

- Export bill
- VAT invoice
- Bill of sale
- Other invoices include: stamps, tickets, cards, insurance receipts ...
- Air freight receipts, international freight receipts, banking service fee receipts, ... the form and content are made according to international practices and the applicable laws relate to.

What should businesses prepare to use electronic invoices?

- Firstly, economic organizations are eligible and are conducting electronic transactions in tax declaration with tax authorities; or is an economic organization that uses electronic transactions in banking activities.
- Second, there must be a location, information transmission lines, information network, communication equipment to meet the requirements of exploiting, controlling, processing, using, preserving and storing electronic invoices.
- Thirdly, there is a contingent of qualified executors, capable of commensurate with the requirements to create, make and use e-invoices according to regulations.
- Fourth is to have electronic signature in accordance with the law.
- Fifthly, there is software to sell goods and services connected to accounting software, to ensure that data of electronic invoices for selling goods and providing services are automatically transferred into the software (or database). data) accounting at the time of invoicing.
- Finally, there are data backup, data recovery and data archiving processes that meet the minimum requirements for quality of storage including: Storage system, backup and recovery process. crash.
