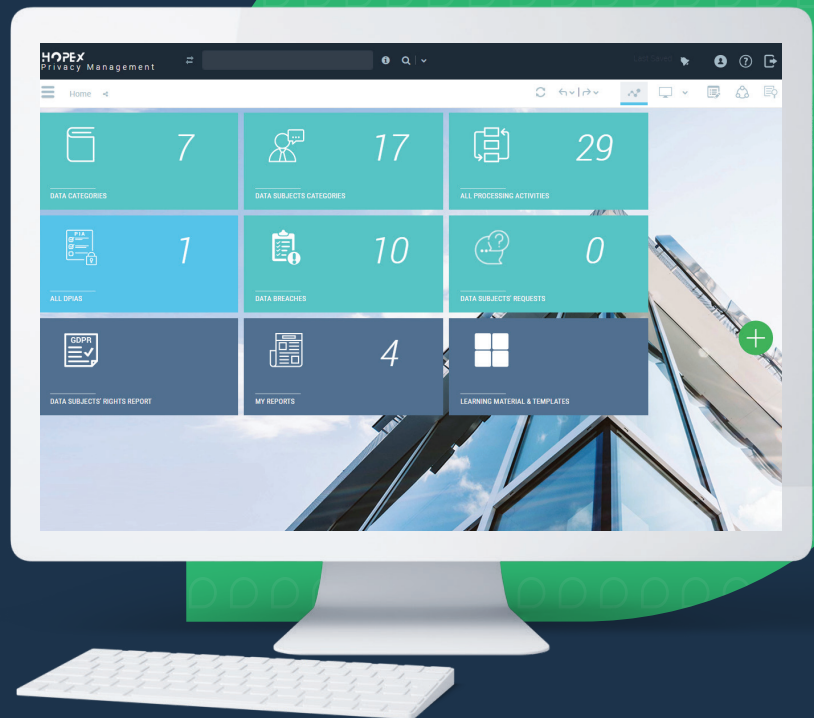

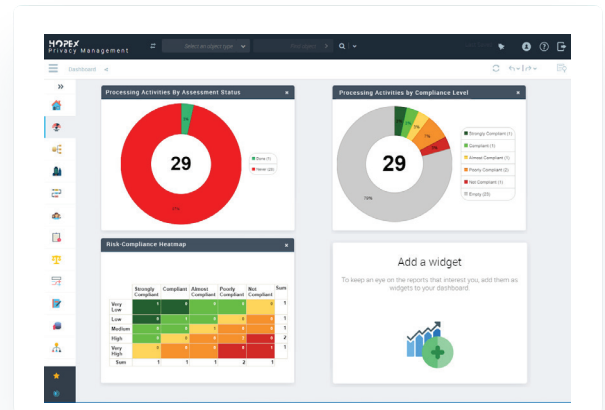

- Build the inventory of your processing activities

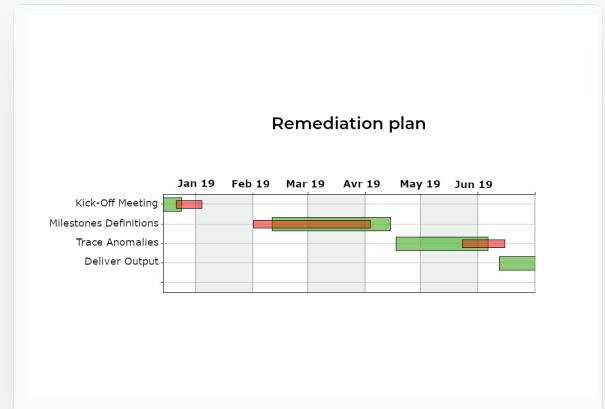

Remediation plan - GANT chart

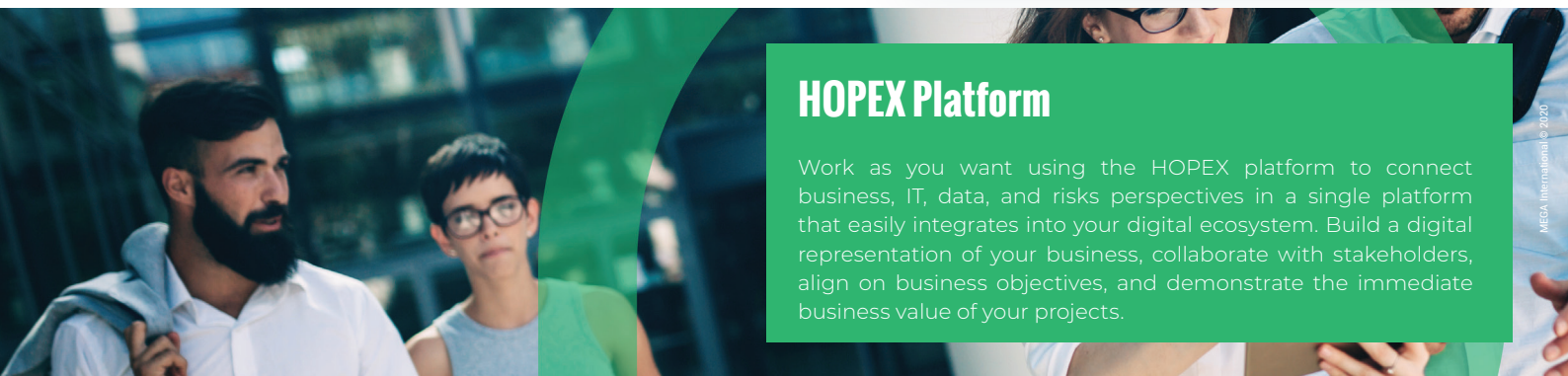
