Electronic Registry

Regista is an entry and exit register software for an organization that provides the classification, distribution and distribution of electronic records for employees in order to quickly find and use the information and specific resolution documents.

- → Documents in progress and overdue
- → Filters and advanced sorting
- → Journaling
- → Archiving nomenclature
- → Reports
- → Nomenclatures of issuers and recipients

Document Management

Managing the workflow between departments, transmitting documents, establishing different levels of access and checking the stage of solving tasks.

- → Document sending flow
- → 3-level organization chart
- → Document access done at the user level or at the entire department level
- → Document status done at the department level





e-Government Portal

The public portal is an extension of the institution's website to facilitate communication with its citizens.

Online status check for bureaucracy

The applicant can check online the status of the submitted documents. Thus, the queues at the counter are eliminated and the activity within the institution is more efficient.

The simple form with only 3 fields to fill in: application number, name and surname of the applicant and year of submission of the application.



Online Payments

Integration of public institutions with Ghiseul.ro for the online payment of local fines, taxes and fees.



Electronic forms

Submitting and issuing documents online

Allows you to fill in and send online the forms required for the issuance of certificates, authorizations and other documents.

Applications received online automatically enter the General Registry flow.

Taxpayers are automatically notified by email.



Online scheduling for audiences, marital status and for issuing or exchanging identity cards or documents.



Reporting an issue from your city area

Map of the area with the submitted notifications filtered by type, condition, period of addition.

The new complaints are positioned on the map and have pictures for a better description of the situation.

Notifications will be approved or rejected depending on the published publication conditions.



Official Monitor

Automatic publication on the portal of public registers and information from local institutions according to OUG no. 57 of July 2019 regarding the Administrative Code.

Online payments and taxpayer's account

Online payments, taxpayer's account with identity verification and electronic signatures.



Citizens will create an account in the e-Government portal to have the history of requests and payments, as well as to have their data pre-filled.



Online payment of fines directly through the e-Government portal.



Online payment of taxes directly through the e-Government portal, as well as when completing an application such as the Urbanism Certificate.



Integration with the provider of taxes and fees so that citizens can pay taxes online directly on the e-Government portal.



We can offer the remote validation of citizens' identities, through video, by a certified provider at European level.



Electronic signature

We can include qualified electronic signature certificates for citizens.
