# DSGVO Toolkit Basic in Detail

## Functional Overview

### Comply with the DSGVO requirements!

At the contact is the storage of processing purposes, declaration of consent, origin and related expiration date enabled to comply with legal requirements.

### Information Report

Article 15 - Right of access by the data subject

At the push of a button a PDF document can be created which shows all data of a contact and its origin. Furthermore the report shows to which internal & external places the data was passed on. So you are able to provide information in case of need..

### Data Transmission

Article 20 - Right to data portability

With a standardized export the personal data can be exported.

### Deletion & Anonymization engine

Article 17 - Right to erasure ('right to be forgotten')

If, according to the processing purpose, the associated expiration date has been reached and there is no declaration of consent in the system that sets a different expiration date, the contact is automatically deleted or anonymized by the system.

### Restriction of processing

Article 18 - Right to restrict the processing

By adjusting the processing purpose of the contact, the wish of the stored person can be met. The system documents that the data will only be used for purposes with appropriate consent.
