


#### Azure Assurance Architecture – How it Works

The images below detail the phases and engagement for Unify Public Cloud for Microsoft Azure.

- Upon signed Client agreement, USDM and Client will schedule a kick-off meeting where USDM will provide the Microsoft Vendor Assurance Report, and subsequent items 2-4, 6 will be exchanged.
- 2. USDM provides Client the Microsoft Vendor Certification
- 3. Client will provide USDM access to their system intended use.
- 4. Client will provide USDM access to their Software and Cloud compliance policies and SOPs (CSV/SDLC).
- USDM works with Client to perform the IS Wellness Check utilizing the Cloud Assurance™ Accelerator.
- Client will provide USDM access to their Configuration documents.
- USDM performs compliance assessment of the provided procedures.
- USDM performs technical assessment of the system configuration.
- USDM drafts Assessment Report utilizing the Cloud Assurance™ Accelerator to summarize and document the results of the assessment activities.
- 10. Client approves Assessment Report.
- USDM provides content for the proposed procedural updates.
- 12. USDM provide details of the proposed configuration undates
- 13. Client approves proposed procedural content.
- 14. Client approves proposed configuration.
- 15. Client updates SOP with approved procedural content.
- Client updates configuration per approved design. OPTIONAL USDM updates configuration per approved design.
- 17. USDM drafts the Compliance Report utilizing the Cloud Assurance™ Accelerator summarizing the results of all recommendations defined in the Assessment Report including the implemented procedural and technical updates.
- 18. Client approves Compliance Report.
- 19. USDM schedules and conducts Value Confirmation meeting with Client.
- 20. All Alignment, Assessment and Implementation activities and results are uploaded to the USDM Cloud Assurance™ Continuous Compliance portal. Client can view the USDM Cloud Assurance™ Continuous Compliance dashboard to visually track key performance indicators, metrics, and key data points to monitor the health of their Cloud Compliance

- 23. Client approves SRS/CS and CQ/PQ. Client approval order may differ from depiction.
- 24. USDM manually executes the Configuration Qualification (CQ) and Performance Qualification (PQ) scripts on the Client environment. OPTIONAL USDM provides automated testing of CQ and PQ.
- 25. Client approves Test Results.
- 26. USDM drafts the Qualification Report utilizing the Cloud Assurance™ Accelerator to summarize and document the results of the qualification activities.
- 27. Client approves Qualification Report
- 28. Client releases system for use. OPTIONAL Additional Workload Migrations to Cloud. Requires scoping based on impact assessments which can include Cloud Assurance™
- 29. All qualification activities and results are uploaded real time to the USDM Cloud Assurance™ Continuous Compliance portal. Client can view the USDM Cloud Assurance™ Continuous Compliance dashboard to visually track key performance indicators, metrics, and key data points to monitor the health of their Cloud Compliance.
