



# Key Features

## Data Management

### File Mapping:

Large datasets can be easily segregated, spot checked and queried, enabling simpler preparation and review. AlphaVAT achieves this by applying conditions to datasets across multiple source files and mapping results into calculation buckets.



### Data Filtering:

Powerful filtering tools allow complex datasets to be easily broken out into the correct accounting treatments for the VAT return, such as reverse charge.

### Managing Blocked/Excluded Transactions:

Easily identify and mark transactions that should be blocked from recovering input VAT or excluded from the VAT calculation.

### VAT Return Diagnostics:

The built-in diagnostics system will advise of any logical errors that occur in the results of the VAT calculation helping to resolve potential issues prior to the submission of the VAT return to HMRC.

## Compliance Engine

### Calculation Reports:

Drill down to the underlying calculation steps and transactional data. Review an entity's past returns, submitted via AlphaBridge or AlphaVAT, and track the rise and fall of payments over time to resolve discrepancies quickly.



### Manual Adjustments:

Any number of adjustments can be made for any box on the return, underpinned by AlphaVAT's robust digital audit trail.

### VAT Groups:

Simplifies the process for handling group VAT returns. Provides automatic consolidation of member calculations and logic to track and apply limits.

### Calculation Transaction Treatments:

Certain categories of transactions, such as reverse charge and acquisitions, are subject to specific treatment in respect of the boxes used on the VAT return. AlphaVAT delivers calculation blocks that handle a range of treatments for these types of transactions.

### Partial Exemption Recovery:

Partial Exemption standard and special method are both supported. Under standard method, transactions are filtered into taxable, exempt and residual while under special method its possible to treat entities, sub entities or specific business activities as different sectors thanks to a range of templates that cover special method scenarios. Over 20 sectors can be supported and, if necessary, each can be assigned a separate methodology.

Attribution of direct and indirect VAT costs can also be automated. Collectively this provides more time to review the recovery calculation and perform manual adjustments at year end.

## Process Management

### Role Based Access Control:

Control user access by entity, folder and group, through the application of a role type. Six roles are currently supported, comprising 'Admin', 'Super User', 'Edit & Submit', 'Edit only', 'Submit only' and 'Read only'. Add an additional layer of control by assigning each user the 'Preparer', 'Reviewer' or 'Submitter' tag. Controls can also be applied to folders, entities and groups.



### Organisational Management:

Easily create and tailor folder structure. Access controls are simple to set up and can be applied to folders to ensure that the right people have access to the right information and that confidentiality requirements are met and upheld.

### Authorisation & Sign Off:


Provide authorisation for AlphaVAT to access an entity's Business Tax Account using built-in processes that are able to complete this mandatory task for each entity quickly and efficiently.

### Entity History and Submission Records:

AlphaVAT automatically creates and stores, by entity, a complete history of all returns fulfilled by AlphaVAT and/or AlphaBridge. This makes it easy to analyse and compare prior submissions using our inbuilt analytics feature.

### Reports, Analytics and Dashboards:

Tax data analytics is provided through a visual, easy to configure dashboard. This helps to identify trends and detect unusual movements, supporting the accurate preparation of VAT returns. Inbuilt logic identifies and reports on potential duplicates, out of period data and unusual VAT rates as part of our source data cleansing.



### Notifications and Alerts:

Inbuilt notifications and alerts provide users with important information about their VAT compliance cycle, such as system notifications from HMRC and reminders of imminent filing deadlines.

## System Security and Filings

### HMRC Compliant API:

AlphaVAT uses HMRC's MTD API to provide the mandatory digital link between the VAT calculations and HMRC. AlphaVAT performs the calculation and populates the nine fields of the VAT return using the source data inputs provided. It can then submit and verify receipt of the return via the HMRC API.

### Multi-site data resilience:


AlphaVAT is hosted at Microsoft Azure's primary and secondary datacentres located in the UK and our APIs are protected with a Layer 7 Web Application Firewall. Azure also meets a broad set of industry compliance standards, including GDPR, ISO 27001, HIPAA, FedRAMP, SOC 1 and SOC 2.

### Two factor authentication:

Microsoft's OpenID Connect is integrated with Azure AD to provide two factor authentication firstly through a password and secondly via a one-time code sent via SMS or voice call.
