



- Partners have a simple, alliance branded experience
- No Guest accounts req'd for partners
- Partners use their existing OpenIDcompatible creds to authenticate
- Modern collaboration experience... co-authoring, versioning, etc.

- All adoption occurred organically, based on word of mouth and accumulating success
- Mostly team-oriented folder sharing from SharePoint...but some sharing from OneDrive
- Multiple strategic projects with C-level visibility & involvement

  - Global Emerging Markets Expansion in consultation with Deloitte
  - Migration of apps to AWS in consultation with Accenture
  - Strategic vision in consultation with KPMG

#### Versus Point Solutions (e.g. Box)


- Natively uses ODB & SPO for all file storage...no copying of files

- Allows SPO users to stay within the native O365 environment
- Leverages your investment in AIP document labels
- Allows more value to be extracted from O365...eliminating the cost & complexity of point solutions

#### Versus O365 without e-Share

- 100% custom branding, instilling trust & eliminating link blocking
- Fine-grained file sharing controls without the limitations of RMS
- Productivity boosting collaboration capabilities...e.g. Share With Me
- Robust API for eDelivery and eCollection ... improving client experience and streamlining ops
- Produces audit logs and analytics not available with SPO/ODB
